CAD **Scrutiny Review of CCTV** 48/17

The Director of Community Services and Care for Your Area Operations Manager presented a comprehensive report on the Council's CCTV service including film footage showing the coverage and quality of the CCTV cameras.

The Council's scheme operates within the boundaries of Stockton-on-Tees and

entirely owned and operated by the Council who are responsible for the management, administration and security of the system. The Council work in close partnership with strategic partners such as the Police, Fire and Rescue, Home Office departments and the Environment Agency.

The network comprises of 173 cameras which are monitored 24/7 in a purpose built control room. The control room are also responsible for monitoring several hundred other cameras,

lone worker devices and intruder and fire alarms for private sector businesses and is

operated on a commercial basis funded by revenue from the private sector.

majority of funding from the Council is from Members' Community Participation budgets.

The service had benefitted from recent investment in the region of £80,000 from the

Council for cameras in Stockton Town Centre. Performance over the past five vears was

set out in the report to the Select Committee and in 2017/18 there had been over 600

arrests, over 4000 reported incidents, 1,120 reviews carried out for the Police and 694

lines of enquiry progressed.

The main issues discussed were as follows:

- •Difficulties in achieving coverage in residential areas
- •The potential for joint working with other Local Authorities
- •The reliance on funding from Members' Community Participation Budgets
- •The requirement for a privacy impact assessment for every new camera and the need

for a proportionate response to problems

•The fast pace of improvements in technology in this area e.g. face recognition and use of drones

The Committee were satisfied that the service was operating a well-coordinated system,

and improvements to the operation of the service meant that this no longer warranted an

in-depth review. However, further information on CCTV coverage across the Borough, including

Councillor supported CCTV, was requested in conjunction with a visit to the upgraded control

room. It was suggested that the opportunity to visit the control room should also be made available to all Members.

AGREED that the information be noted and further information on CCTV coverage across the Borough be provided to Committee in conjunction with a visit to the upgraded control room.
