<b>Recommendation 1:</b>	<p>To develop a resource pack for all schools to assist them with delivering a range of measures within Stockton Borough to help address the issue of parking outside schools. This could include:</p> <ul style="list-style-type: none"> <li>• Developing a school/pupil champion as a school lead for the dissemination of: information/raising awareness / encouraging alternative/sustainable travel to and from school / a campaign involving travelling to school to help parents make informed choices;</li> <li>• Developing informal parking charters to be signed by parents.</li> <li>• Developing informal friendship stops where parent volunteers could provide a walking bus and informal arrangements for drop off;</li> <li>• Introducing an annual Award Scheme to recognise borough-wide achievements;</li> <li>• A video resource for schools to highlight the issues dealt with by Enforcement Officers</li> <li>• Promote and extend the advisory service on request to head teachers/school governors to determine measures that individual schools could take to reduce the issues and incidences of car parking at schools</li> <li>• A summary of the powers available to schools to manage traffic/parking on school grounds</li> </ul>

<b>Agreed Action:</b>	<ul style="list-style-type: none"> <li>• Junior Road Safety resource pack being developed with Communications Team and will be rolled out to schools with a roadshow being developed.</li> <li>• As part of pack, offer a draft parking charter which will be available for schools.</li> <li>• Friendship stops to be identified for walking buses in line with requests from schools.</li> <li>• Following a period of monitoring award to be developed potentially as part of annual road safety quiz.</li> <li>• Enforcement have video clips available, budget to produce video resource being sought.</li> <li>• Information to be provided to schools as requested.</li> </ul>

Award scheme to be developed, achievements to be recognised could include % of parents participating in parking pledge as well as participation in JRSO. Recognition potentially to be part of Annual Quiz.

	<b><i>update on the production of a Stockton-on-Tees school parking video to be provided at a future Committee meeting.</i></b>
Evidence of Progress (November 2020):	<p>Following on from the last committee that this was discussed at, a local videographer was approached and the Road Safety team invited all schools to participate in the project. The schools were asked to provide posters around journey to school or school parking.</p> <p>A total of 37 posters - 5 schools sent in 6 posters and 1 sent in 7 posters were received. Some schools have gone with a theme but there is enough of a variety to be able to use.</p> <p>Some have sent in messages that can be spoken and 1 school has sent a very short video with 6 children holding up their artwork and saying their message.</p> <p>The videographer will be filming at the schools after half term and will introduce an abridged version of the Cambridge road safety song into our film.</p>
