SCRUTINY REVIEW OF PUBLIC SPACES PROTECTION ORDERS (PSPOs)

Summary

The fourth evidence-gathering session for the Committee's review of Public Spaces Protection Orders (PSPOs) is scheduled to receive contributions from other Local Authorities who have implemented a PSPO, Stockton Business Improvement District (BID), and will also reflect on alternative views surrounding PSPOs.

 - Rationale for introducing a PSPO
 - Consultation undertaken / objections faced
 - > When PSPO introduced / area covered / restrictions
 - Enforcement of PSPO available resources and any challenges / data on FPNs issued and paid
 - Ultimate impact of implementing the PSPO on addressing identified anti-social behaviour (ASB) – how is this measured / reviewed?
 - > Perceived implications if the Council did not introduce the PSPO
 - Reports on behalf of each organisation are attached.

In addition to the information provided at this meeting, the Local Government Association (LGA) published a series of Council case studies on tackling ASB in June 2021. Providing experiences and best practice in addressing and preventing ASB, as well as promoting the 'Community Trigger' process, further details (including a useful 'lessons learned' section within each case study) can be found at the following link:

- 4. In order to consider a balanced range of opinions around the issue of PSPOs, attention is also drawn to a number of other views on the use of such Orders (see attached report).
