'I am glad to hear that the council intends to tackle the aggressive begging practices in the town centre.

I remember walking to work in the early hours and being approached by up to five beggars. Just going to get lunch could be an ordeal.

However, I do question the use of a PSPO.

The penalty for breach is a penalty notice (which will likely go unpaid) and then prosecution. The only sentence available to the court would be a fine (see s67 of the ASB Act 2014). Clearly, if they are begging, they are unlikely to pay any fine and the behaviour is likely to continue unabated.

A more useful tool would be an anti-social behaviour injunction (ASBI).

The injunction is applied for in the county court and a breach of the same can lead to a custodial sentence for contempt. This is, in my view, a more effective means of dealing with the issue.

It also removes the potential negative press around 'criminalisation' as these are purely civil matters.

I am a lawyer for another local authority and would encourage you to seek advice from your officers on the appropriate use of ASBIs to deal with the issue; rather than reliance on a PSPO which will do little to solve the issue overall.

I hope you investigate this a little more carefully with you officers to evaluate if this is perhaps a better approach, or even one which should be used in conjunction with the PSPO.'

'I've had a worrying report from one of our service users this morning. He's said that he and another of our team were approached by a group of people begging for money in the town centre. Upwards of 10. Apparently there was a PCSO but that didn't stop them from approaching, he's a bit shaken up by it, he didn't given them money but I'm concerned as more of our users are going back to independent travel that they could feel forced to give money over. He wasn't alone as another participant was with him but they are a little less aware of the potential danger. I thought it was worth raising to you, hopefully to raise it just in case there's no awareness of this.

It was at about 8:20am and it's not an isolated incident, apparently the group regularly walk around the bus stops at this time asking people for money.

Is there an appropriate non-emergency number to ring? One thing that springs to mind is the safe place scheme. They're at the stops around T, just near the top of wellington square. I was going to research whether there were any businesses currently there that are part of the scheme. I don't want the fear of being approached, or worse to reduce their independence.'
