ENV EIT Review of Built and Natural Environment - Action Plan for Agreed 42/10 Recommendations

Members were presented with the action plan for review of Built and Natural Environment recommendations for their approval.

Members queried whether savings from the reduction of school crossing patrols would be used to install more puffin crossings. Officers advised that savings would be on revenue but it was hoped that there would be scope to direct some capital investment to install additional puffin crossings.

Discussion took place regarding the negative media coverage in respect of the proposals to remove some school crossing patrols. Members referred to the Oxbridge crossing and suggested that signs could be erected to warn drivers of

the school crossing.

Discussion took place regarding the fact that estimated savings on the production and issue of the blue badge scheme would not be as much as originally estimated due to the reduction in funding from central Government. Officers advised that discussions would take place on the allocations with Government.

Members commented on the importance of having better blue badge access in town centres.

CONCLUDED that the action plan be agreed.

CARBON MANAGEMENT

Members were advised that carbon trading had been replaced by a carbon tax but Councils were still being incentivised to reduce carbon.

Members were provided with a presentation highlighting the progress which had been made in implementing the recommendations from the previous reviews.

Discussion took place regarding memorial inspection and repair and the checks carried out on memorial masons.

Discussion took place regarding the proposals for extending memorial options.

Discussion took place regarding the need for a crematorium in Stockton and Members wished to record their support for a facility within Stockton Borough.

Members wished to express the Environment Committee's support for the effort of the Head of Performance and Business Services and all other officers involved with implementing the reviews.

CONCLUDED that the updates be noted and the assessment of progress be endorsed.
