- A co-ordinated approach to ICT for the new academies. Richard McGuckin to come back in the Autumn with an update.

Environment Services Overview

Members were provided with an overview of Direct Services by Richard Bradley and Technical Services by Richard McGuckin and Bereavement Services by Sue Daniels. The key achievements for each service were highlighted together with emerging issues. The following points were highlighted by the Committee:-

- High customer satisfaction levels for refuse collection, recycling facilities and street cleansing.
- Lack of Council control regarding with cleansing of privately owned areas such as shopping parades etc.
- High performance levels for street cleansing.
- Numbers of missed bins extremely low.
- Lack of facilities for disposal of food waste, although there was commercial interest in developing an anaerobic digestion plant. This would need to be taken forward in conjunction with other Tees Valley Council's.
- Carbon Management programme was on target.
- Street Lighting, photocell replacement and dimming programme complete.
- Rolling out installation of electric car recharge points at various locations within the Borough.

AGREED that the overview of the Service be noted.

EIT Review of Care for Your Area Services

- Vehicle Maintenance and Workshops

Members raised the following issues:-

- The impact of rising fuel costs
- Damage to footpaths due to tree roots
- Types of receptacles for recyclable materials
- Arrangements for disposal of prunings etc. that need to be carried out later in the year when there are no green waste collections.
