#### Children & Young People

##### **Maintaining**

- **CYP001 (BV 181a)** - The percentage of 14 year old pupils in LA maintained schools achieving Level 5+ at Key Stage 3 in English
- **CYP006 (BV 40)** - The percentage of pupils in LA maintained schools achieving Level 4+ at Key Stage 2 in Maths
- **CYP019 (Ch040)** - Number of local authority SRAS schools (Schools Requiring Additional Support) at Level 3 which move on to an Ofsted designation

##### **Declined**

- **CYP008 (BV 162)** - The percentage of child protection cases which should have been reviewed during the year that were reviewed
- **CYP009 (BV 49)** - The percentage of looked after children with 3+ placements during the last financial year
- **CYP016 (Ch035)** - The percentage of children achieving Early Learning goals by final term Foundation Stage in PS&ED (Personal, Social and Emotional Development) LPSA 2004-07

#### Healthier Communities & Adults

##### **Maintaining**

- **HCA001 (BV 54)** - older people helped to live at home, per 1,000 population aged 65+

##### **Declined**

- **HCA005 (BV 161)** - the ratio of the percentage of those young people who were looked after on 1 April in their 17th year (aged 16), who were engaged in education, training or employment at the age of 19 to the %age of young people in the population who were engaged in education, training or employment at the age of 19

#### Liveability

##### **Maintaining**

- **LIV001 (BV 84a)** - Number of kilograms of household waste collected per head of the population
- **LIV009 (BV 66a)** - Rent collected by the Local Authority as a proportion of rents owed on Housing Revenue Account (HRA) dwellings

##### **Declined**

- **LIV004 (E004)** - Number of sanctions of offenders for dumping, littering or dog fouling
- **LIV008 (BV 64)** - Number of non-local authority-owned vacant dwellings returned to occupation or demolished during the financial year as a direct result of action by the local authority

### **Declined**

- **CH002 (BV 8)** - Percentage of invoices for commercial goods & services paid by the Authority within 30 days of receipt or within the agreed payment terms
- **CH004 (BV 10)** - The percentage of national non-domestic rates collected in-year
- **CH005 (BV 12)** - The number of working days/shifts lost to the Authority due to sickness absence
