SELECT COMMITTEE WORK PROGRAMME

SUMMARY AND RECOMMENDATION

The report asks Executive Scrutiny Committee to approve and allocate the ongoing scrutiny work programme.

WORK PROGRAMME

1. Over the past two years the Scrutiny work programme has focused on providing support to the Council's Efficiency, Improvement and Transformation (EIT) programme with Member involvement in all reviews.

2. All reviews for Years 1 and 2 have or will be completed by the end of the 2010/11 municipal year with the exception of the following topics:

- Children and Young Peoples Assessment/ Field Work
- Mental Health and Learning Disability

3. At their last meeting, Executive Scrutiny Committee allocated the review of Mental Health and Learning Disability to Health Select Committee to agree a scope for review and undertake some preliminary work ahead of the May elections with work continuing into the 2011/12 municipal year. In addition, on 19 October, Executive Scrutiny Committee took a decision to expedite some Year 3 EIT reviews into the current year.

4. Remaining review topics for the Year 3 EIT Programme are set out below with a suggestion for how they might be allocated to Select Committees. Given that Year 3 reviews have already been prioritised for scrutiny by the Scrutiny Liaison Forum and the number of reviews to be undertaken as part of Year 3, it is proposed that Executive Scrutiny Committee agree the work programme without the need for a further meeting of the Scrutiny Liaison Forum. Whilst recognising the priority of the EIT programme, Executive Scrutiny Committee still retains the flexibility to review it in the light of any emerging issues within year.

Beccy Brown will be lead officer for this review.
