




**Extract from Constitution – Article 13.02**

- All decisions of the Council will be made in accordance with the following principles:
- proportionality (ie. the action must be proportionate to the desired outcome);
  - due consultation and the taking of professional advice from officers;
  - respect for human rights and equality of opportunity;
  - a presumption in favour of openness;
  - clarity of aims and desired outcomes;
  - an explanation of what options have been considered and giving the reasons for decisions.

## CALL IN REQUEST – BOROUGH WIDE CAR PARKING STRATEGY

The reasons for the call in of this Cabinet decision are identified in Article 13 of the Council's constitution.

**Proportionality:** - The allocation of additional short stay parking in Yarm will detract from the number of long stay spaces thereby causing the migration of commuter parking to streets in nearby communities. There is also a disproportionate impact on local residents that live on Yarm High Street or in the vicinity.

**Due consultation:** - There has been no specific consultation with residents and occupiers of properties affected by the displacement of commuter parking and the Town Council consider that they were not consulted on the proposals submitted to cabinet but only informed of the recommendations prior to the meeting.

**Equality:** - The recommendations do not give a proportionate and equal scenario for each of the Town Centres within Stockton Borough but concentrate on a charging policy for only Yarm.

**Clarity of aims and outcomes:** - There is insufficient information in the report to support the recommendations and the detailed survey results have glaring inaccuracies that need to be challenged.
