Stockton Borough Council is the Lead Local Flood Authority in its area and therefore has duties and responsibilities relating to flooding from local sources. Local sources include ordinary watercourses, surface water and groundwater.

Stockton Borough Council as LLFA has the duty to investigate flooding events when considered necessary or appropriate under Section 19 of the Flood and Water Management Act 2010.

The Tees Valley Strategic Flood Risk Partnership agreed that an investigation for a flood event, is deemed locally significant and considered appropriate, if one or more of the following is affected by flooding: 5 or more residential properties; 2 or more businesses; 1 or more critical services; 1 or more transport links (Impassable for 10 Hours or more) Stockton has suffered from some severe flooding in the last few years.

Damage to/maintenance of grass verges

Parking on grass verges is a persistent problem as it can not only reduce a verge to an unsightly state, but it can also obstruct the highway and prevent pedestrians and wheel chair users from accessing roads and footways if there is no other pathway. Verge parking can also cause a hazard to other motorists especially if the vehicle is parked on a bend, narrow road or junction.

A review of Pavement Parking was undertaken by the Regeneration and Transport Select Committee between September 2008 and March 2009. A number of recommendations were agreed including the production of Parking on Pavements: A Residents Guide which states that "Vehicle trespass can also lead to damage to underground services, therefore regular inspections and repairs take place costing the Council £300,000 annually."

As this problem persists it should be revisited to determine whether other actions should be introduced.
