This includes an overview of performance across the Trust against a number of key indicators, performance against last year's priorities for Quality Improvement, and outlines next year's priorities. The Committee is able to submit a statement of assurance to the published version.  Visits to Frontline Services – In March Members visited the Allensway Centre for adults with complex needs.  Quality Standards Framework – The Committee considered the Phase 1 Results of this Council-run Quality monitoring and improvement scheme and these focussed on Older People's Care Homes with Nursing. The Committee requested further detail on scoring where appropriate as part of future rounds.
