REPORT OF THE DEPUTY CHIEF EXECUTIVE

SCRUTINY WORK PROGRAMME 2018/19 – SELECTION OF IN DEPTH SCRUTINY REVIEWS

SUMMARY

The report presents proposals for the Scrutiny Work Programme for 2018/19.

- (2) That Executive Scrutiny Committee receive a mid-year update on the progress of the Work Programme.

OUTSTANDING TOPICS FROM THE CURRENT YEAR

- A busy programme in 2017/18 and additional in year referrals from Cabinet has resulted in a number of reviews starting later in the municipal year. In addition, the following topics have not yet commenced and it is suggested they are rolled over into the New Year:
 - Digital Optimisation
 - Food Hygiene
 - Consolidation of Thirteen Group
- 3. In addition, each of the five Select Committees has already commenced a review from the 2017/18 programme and this work will continue into the next municipal year.
- 4. Any reviews that start this year will have to be completed ahead of the purdah period prior to the 2019 local elections and there will not be the flexibility for reviews to straggle years as had been the practice.

SUGGESTED TOPICS FOR 2018/19

PICK System

- 5. The process for work programme setting was reviewed last year to place even greater emphasis on efficiency and review outcomes focusing on reducing demand for services. In inviting topic suggestions, Members were also reminded that the scrutiny work programme should be seeking to support the Council's policy principles. Councillors and officers were invited to submit topic suggestions for the scrutiny work programme for 2018/19.
- 6. In addition, services were asked to propose possible in depth review topics as part of reports presented to Select Committee overview meetings. In inviting topic suggestions,

the Chair of Executive Scrutiny Committee has stressed that it is imperative that in depth scrutiny reviews focus on topics which are in line with the Council's policy priorities and seek to identify efficiencies and reduce demand for services.

- 7. Every effort has been taken to focus attention on suitable priority topics with proposals considered and justified on the basis of public interest, impact, performance and efficiency issues and context. This PICK system approach allows a score to be given to each suggestion to help with prioritisation of topics. It should be stressed that the score is a tool to aid prioritisation and is not binding in any way.
- 8. All of the appropriate suggestions received are summarised in the schedule set out in **Appendix 1** and given a PICK score.
- SLF was invited to identify the priorities for scrutiny reviews for 2018/19 for consideration by Executive Scrutiny Committee. Appendix 2 sets out how reviews could potentially be allocated to Select Committees.
- 10. Each suggestion is cross referenced with supporting information, and all suggestions received are outlined at **Appendix 3**. (An explanation of the PICK scoring method is attached at **Appendix 4**).

OTHER SCRUTINY WORK

Overview and Monitoring

11. Recognising the overview role of the scrutiny function, annual overview meetings were established to provide Members with an overview of all the services reporting to the various Select Committees and to question Cabinet Members and Senior Officers on their performance and understand the challenges and issues arising ahead of the next year's programme. In addition, Select Committees continue to receive progress reports in respect of the reviews which have concluded until they have been fully implemented.

Quality and Safety

12. In response to high profile cases in the media relating to the quality and safety of health, children's and social care services and the increased expectation on Councils to put in place internal mechanisms to undertake rigorous internal review and challenge, Children and Young People Select Committee now receive regular performance reports in respect of children's services. Adult Services and Health Select Committee also receive performance reports on adult social care issues and a range of other reports and updates are provided as part of the enhanced performance management arrangements. These include Annual Reports from the Council, Trusts and CQC, NHS Local Accounts; CQC Inspection Reports; Healthwatch Enter and View Reports etc. Member site visits to frontline services take place on a rolling programme. The last Ofsted Inspection recognised the work of Children and Young People Select Committee and, in particular, the extensive work to scrutinise frontline practice.

Health

- 13. Adult Services and Health Select Committee continues to be responsible for receiving statutory and non-statutory health consultations / updates on service changes. It is therefore important to build in a degree of capacity within the programme to deal with other emerging issues.
- 14. It is not currently foreseen that consultation on acute services reconfiguration (under the STP process) will take place during 2018. However the STP Joint Scrutiny Committee continues to meet in advance of confirmation of next steps from the NHS leadership of the STP process. During 2017-18, other service change proposals have been

considered. The CCG's Respite and Short Breaks consultation covering the Tees area necessitated the establishment of a statutory Joint Committee of affected Authorities in order to respond, and this continues to meet until outstanding issues are resolved. Stockton has chaired and supported this Joint Committee.

- 15. The Regional Health Committee has this year so far particularly focussed on monitoring proposed regional service changes via NHS England, and together with the Tees Valley Committees close monitoring the NE Ambulance Service (NEAS).
- 16. The Tees Valley Joint Health Scrutiny Committee continues to meet quarterly to scrutinise issues and NHS services which are provided across the Tees Valley sub region. Local Directors of Public Health will be invited to provide suggestions for the forthcoming year. Stockton is due to host and chair the Tees Valley Committee during 2018-19 under the rotational arrangements.

Crime and Disorder

17. Crime and Disorder Select Committee has been the designated statutory scrutiny committee to cover crime and disorder issues as legislatively required (including an annual update on crime and disorder as a minimum. The Committee this year also examined Security in Preston Park and has commenced a review of CCTV. In addition, scrutiny work is carried out by the Cleveland Police and Crime Panel.

Police and Crime Panel

- 18. The Police and Crime Panel has undertaken several task and finish reviews in supporting and reviewing the Police and Crime Commissioner's work. This work is supported from the Council's Scrutiny Team. In 2017/18 topics have included:
 - Shared Services current review final report approved by Police and Crime Panel in September
 - Off Road Motorcycling work commencing initial meetings held on 15 November 2017 and 22 January 2018. Meetings will resume in the autumn to assess the roll out of Operation Endurance
 - Overall Budget Strategy Final report considered at the February PCP meeting endorsing the PCC's precept proposal
- 19. Confirmatory hearing for the appointment of the new Chief Constable was held in January.

SCRUTINY LIAISON

20. Scrutiny Liaison Forum met on 14 March 2018. Comments from the Forum have been included at Appendix 1. The Forum recommended that topic suggestions on School Crossing Patrols, Parking on Grass Verges and Affordable Warmth should be kept on a reserve list of topics should there be any capacity to carry these out and that Executive Scrutiny Committee should receive a mid-year update on the progress of the Work Programme.

CONSULTATION

21. Councillors and officers were asked to propose topics for the scrutiny work programme. Discussions also took place at Select Committee overview meetings during February/ March.

FINANCIAL AND LEGAL IMPLICATIONS

22. The work programme is resourced within existing budgets. No legal implications are identified at this stage.

RISK ASSESSMENT

23. There is a need to meet legislative requirements and for the Council to put in place internal mechanisms to ensure the safety and quality of key services in addition to deploying resources in the most effective way. The selection of appropriate topics for review can help to support service improvement; the selection of inappropriate topics will lead to the waste of officer and Member time and resources.
