Requests for more information	<p>A new schedule of frontline visits is being drawn up (including visits associated with the Homelessness review).</p>

NHS Updates / Consultations

Key Issues / Problems or concerns	<p>Sustainability and Transformation Plan (STP) / Integrated Care System (ICS)</p> <p>The statutory Joint Committee has been formed by all seven affected Authorities (including North Yorkshire) in order to consider proposals emanating from the STP/ Integrated Care System process.</p> <p>The previous proposals related to the Better Health Programme will not now be taken forward, and the Committee is pressing for updated public communications and progress on alternatives from the region's NHS.</p> <p>Information on new approaches to engagement were outlined at September's meeting.</p> <p>Local hospital Trusts have appointed Ian Carruthers to examine more options for collaboration. More information on this has been requested from the Foundation Trust Chief Executives in November.</p> <p>Tees Respite and Short Breaks Review</p> <p>Middlesbrough and Redcar and Cleveland Councils have made referrals to the Secretary of State on this matter. Any future changes to services will be monitored by Tees Valley Committee following the completion of the referral process.</p> <p>Birchtree Practice</p> <p>On 2 October the CCG updated the Committee on the decision to close the specialist Birchtree Practice. This provides primary medical care for people receiving substance misuse treatment (substance misuse services will continue to be provided by the CGL service).</p>
Requests for more information	<p>The Committee requested further updates on the implementation of the changes at Birchtree and will monitor these in due course.</p>
