3/19** **Minutes of the meeting which was held on 19th February 2019**

4/19** **Scrutiny Work Programme 2019/20 - Selection of In-Depth Scrutiny Reviews**

The Committee received a brief overview of its role, prior to considering a report that detailed the suggested Scrutiny Work Programme for 2019/20.

The process for work programme setting was identified using the PICK system. The Scrutiny Liaison Forum (SLF) had prior to the local elections been invited to identify priorities for scrutiny reviews for consideration; the details of which were set out at Appendix 2, and these had been agreed by this Committee at its meeting held in February 2019. The Committee also agreed that an emergency issue relating to the Protection of Vulnerable Older People Living at Home would be immediately commenced by the Crime & Disorder Select Committee. It was proposed that this work be continued by the same Committee in the new Municipal Year. It was suggested however that the proposed review of Action Fraud by the Committee be carried out immediately after the review of Protecting Vulnerable Older People, instead of Roadside Advertising.

The Committee agreed to add SWIS Accommodation review to the People Select Committee Work Programme as a Task & Finish Work Group.

Members also suggested that consideration be given to the review of Domestic Abuse by the Children & Young People Select Committee being carried out as a

higher priority. It was agreed that this review could be carried out by a Task & Finish Group of the Committee alongside the review of Careers Provision; the groundwork for which had already been prepared.

RESOLVED that subject to the amendments above the scrutiny work programme be endorsed.

5/19** **Overview and Scrutiny - End-of-Term Report 2015-2019**

It was noted that the Select Committee that carried out the review would receive an annual update on progress, and that this particular review recognised that parking improvement schemes often facilitated on-street parking measures.

The Centre for Public Scrutiny (CfPS) had also updated its guidance; a link to which would be circulated to the Committee, and Scrutiny Officers had also updated and circulated the Council's own Scrutiny Toolkit.

The valuable contribution that Scrutiny was able to make was highlighted by the fact that, as a consequence of an earlier Scrutiny Review, defibrillator devices had been introduced in various locations around the High Street, including Stockton Central library. It was noted that lives had been saved thanks to their use.
