<b>Achieved since last meeting</b>	<p>The CQC ratings for Care Homes for Older People in the Borough are lower than the national average. The review is seeking to understand the reasons why Care Homes are not achieving the same level of CQC ratings as the Tees and national average and to identify what activities can take place by the Care Homes, Local Authority and wider stakeholders to improve CQC ratings.</p> <p>Care Home visits continue by Committee Members have also taken place</p> <p>The October meeting of the Committee received evidence from the Care Quality Commission and Healthwatch and the November meeting will be hearing from Good and Outstanding Providers</p>
