Achieved since last meeting	Following approval of this CCfA request at the Executive Scrutiny Committee in July 2019, the Committee met on the 24 th October 2019 and heard evidence from Ward Councillors (who submitted the CCfA request), Local Authority Officers, Whitehouse Primary School personnel, and identified representatives of affected residents. In related matters, the Committee also considered a further progress update in relation to the outstanding recommendation from the review of School Parking (see 'Monitoring' table below). Prior to the Committee meeting, Members took part in visits to the school on the 23 rd October 2019 (pm) and 24 th October 2019 (am) to gain a greater understanding of the geography in question. During these visits, a number of parents / carers expressed their views on parking issues affecting both the Dunelm Road and Barlborough Avenue sides of the school.

Key Issues / Problems or concerns	School Parking During the Committee meeting on the 24 th October 2019, Members received a further progress update in relation to the outstanding recommendation from the review of School Parking. A road safety video from Cambridgeshire County Council was shown which has been identified as a potential tool to share with schools - if appropriate a future 'Stockton' video of similar format could be pulled together. The Committee agreed that the video could be a powerful tool in encouraging responsible parking, but deferred the sharing of this resource to enable consideration on using the Cambridgeshire one or commissioning a Stockton version. In light of this and the ongoing CCfA regarding Whitehouse Primary School, the signing-off of the School Parking review Action Plan was delayed until a future Committee meeting.
