Scrutiny Review – Hosp	oital Discharge
Achieved since last meeting	An evidence-gathering session involving South Tees Hospitals NHS Foundation Trust was scheduled for the Committee meeting in March 2020. However, due to the escalating Covid-19 situation, Trust representatives had to cancel on the morning of the meeting. Following the hiatus caused by the pandemic, a tri-partite meeting took place in July 2020 to facilitate discussions on the future direction of this review. The existing scope focused on hospital discharge to an individual's own home, not to care homes. Discharge to care homes during the Covid-19 pandemic had been a well-publicised issue, something that the Committee may now want to explore whilst being mindful of the ongoing organisational pressures Trusts and care homes continue to face.
	In July 2020, the Committee agreed to split this review into two phases - phase 1 would be a short, focused piece of work on discharge to care homes during the pandemic, followed by phase 2 which would see a resumption of the originally agreed scope, namely, discharge to an individual's own home.
	Two evidence-gathering sessions have been held in September 2020 which considered evidence in relation to phase 1 (discharge to care homes) from both North Tees and South Tees NHS Trust's, as well as the Local Authority. An intended informal session for care homes did not take place due to issues in getting representatives to agree to participate in a meeting — as such, a survey has been collated and sent to all care homes across the Borough in an attempt to obtain written submissions.

Key Issues / Problems or Concerns	CQC Report Updates: These continue to be considered on a quarterly basis. The Q4 2019-2020 report was presented to the Committee on the 21 st July 2020 (delayed due to Covid-19) where Woodside Grange and St Mark's were discussed in detail. The Q1 2020-2021 report was considered by the ASCH Select Committee in September 2020 – this was very brief as the CQC inspection programme was suspended during most of the reporting period (April to June 2020) due to Covid-19.
	NTHFT Quality Account 2019-2020: North Tees Trust presented their Quality Account for 2019-2020 at the Committee meeting on the 10 th March 2020. The draft QA document was circulated to the Committee following the March meeting, and a Statement of Assurance on behalf of the Committee was produced – this was sent to the Trust for inclusion in its final Quality Account document in early-May 2020.
Requests for more information	NTHFT Quality Account 2019-2020: The Committee requested data around re-admittance from the Discharge Lounge, as well as more detail on why the new <i>C Difficile</i> Community onset Healthcare Acquired measure was added, along with some narrative around this data and the combined target with <i>C Difficile</i> Hospital onset Healthcare Acquired – the Trust have since provided this information.

Key Issues / Problems or Concerns	Sustainability and Transformation Plan (STP) / Integrated Care System (ICS): The statutory Joint Committee has been formed by all seven affected Authorities (including North Yorkshire) in order to consider proposals emanating from the STP / Integrated Care System process.
	Due to the General Election, the scheduled meeting of this Joint Committee on the 26 th November 2019 was cancelled. It remains uncertain when the next meeting will take place considering the ongoing Covid-19 situation.
	CCG Mergers : Following completion of the consultation process on the proposals for merging Clinical Commissioning Groups in the Durham and Tees areas, the new Tees Valley CCG came into operation on the 1 st
