Key Issues / Problems or Concerns	CQC Report Updates: The Q2 2021-2022 report was considered by the Committee in November 2021. Updates in relation to Piper Court and Rosedale were also provided, and several PAMMS assessment reports were reflected upon. Members were also given an update on unvaccinated care home staff and the impact of this on local providers.  Healthwatch Stockton-on-Tees – Annual Report 2020-2021: The Committee considered this Annual Report in November 2021. Members were keen to know when Healthwatch would be resuming their 'enter and view' programme – this would be taken back to the Healthwatch Board to clarify the current and future position.
	CQC – State of Care 2020-2021: The CQCs latest assessment of health care and social care in England was published in late-October 2021 and was circulated to the Committee for information. CQC representatives were scheduled to attend the Committee meeting in December 2021 to give their annual presentation on this report, along with some reflections on the local health and care scene, but concerns around the latest COVID variant had led to CQC staff being advised not to attend face-to-face meetings. As this item involves holding the CQC to account (which must be done in a publicly-accessible forum), it was deferred to the next Committee meeting in January 2022.
