Scrutiny Review – Bonfires on Public Land	
<b>Achieved since last meeting</b>	<p>The final evidence-gathering session for this review was held in May 2022 and included the deferred (from April 2022) presentation from Cleveland Fire Brigade and a contribution from Thirteen Housing Group. Input from the RSPCA had also been sought for this meeting, but no reply was forthcoming.</p> <p>Following completion of the evidence-gathering, the Committee met informally in June 2022 to consider a summary of the evidence received for this review and formulate draft recommendations.</p>

<b>Planned next month</b>	An end-of-review tri-partite meeting will take place before a draft final report is presented to the Committee in July 2022 for comment and approval.
