Scrutiny Review – Hospital Discharge	
<b>Achieved since last meeting</b>	A draft scope and plan was considered and agreed by the Committee in January 2020. Focusing on those people discharged back to their own home (not care homes), this review will examine the current discharge process, communication between partners, feedback from patients, and measures put in place when carers have to go into hospital to ensure that the person left at home has the support they need.

<b>Planned next month</b>	The first evidence-gathering session will take place in February 2020 and will involve contributions from North Tees & Hartlepool NHS Foundation Trust, NHS Hartlepool and Stockton-on-Tees Clinical Commissioning Group, and the Local Authority.

<b>Key Issues / Problems or concerns</b>	<p><b>Sustainability and Transformation Plan (STP) / Integrated Care System (ICS)</b></p> <p>The statutory Joint Committee has been formed by all seven affected Authorities (including North Yorkshire) in order to consider proposals emanating from the STP / Integrated Care System process.</p> <p>Due to the General Election, the scheduled meeting of this Joint Committee on the 26<sup>th</sup> November 2019 was cancelled. A replacement date early in the New Year is intended.</p>
<b>Requests for more information</b>	The STP Committee will receive information on the development of Primary Care Networks at a future meeting.

<b>Key Issues / Problems or concerns</b>	<p><b>Tees Valley Committee:</b> Hartlepool BC are chairing and supporting this Committee during 2019-2020 under the rotational arrangements.</p> <p>The last meeting took place on the 17<sup>th</sup> January 2020, where a positive performance update was received from the North East Ambulance Service (NEAS), concerns were expressed around the Repeat Prescription Ordering Service, and details from TEWV on progress of their half-yearly Quality Account, an update on the ongoing remedial works at Roseberry Park, and their Right Care Right Place programme was given.
