# PRIVATE HIRE AND HACKNEY CARRIAGE LICENSING POLICY AMENDMENTS - CONSULTATION

#### **SUMMARY**

The purpose of this report is to update Members on a recent Private Hire and Hackney Carriage Policy consultation and provide further information which was requested at the licensing committee hearing on 27 August 2019.

#### **RECOMMENDATION**

Members' comments are received on proposed changes to the current policy.

#### <u>Detail</u>

- 1. At the Taxi Trade meeting in June 2019 private hire operators in attendance requested formal consideration of proposed amendments to the Private Hire and Hackney Carriage Policy. In addition a request was received from the chairman of the Stockton Hackney Carriage Driver Association (SHCDA) for an amendment to policy. The requested changes to the current policy could bring licensed driver and vehicle requirements and specifications in line with the neighbouring Tees Valley Licensing Authorities.
- 2. A 28 day period of consultation was undertaken giving all stakeholders opportunity to comment of the proposed changes. The electronic consultation survey was sent to all licensees via the Trade Times. In addition the link was emailed to private hire operators, SHCDA, other local authorities and the police. The consultation has now closed and details of the responses are attached at Appendix 1.

#### 3. New Applicant DVLA licence requirement

The trade have requested the current policy is amended for new applicants to have held a full DVLA licence for 12 months rather than the current policy requirement of three years. The trade have commented this higher requirement is making it increasingly difficult to recruit new drivers, the trade raised issues raised regarding cross border applications with other authorities and requested the need for an equitable approach across the Tees Valley.

- 4. Members should note that it is a legal requirement under section 51 of The Local Government Miscellaneous Act 1976 for new applicants to have held a full DVLA licence for 12 months only before a licence is granted. The current three year requirement was introduced by this authority at the 2016 transport policy review and was based on LGA guidance that had just been released.
- 5. The other Tees Valley Authorities did not adopt the LGA guidance on this matter and therefore only require the applicant to have held a licence for 12 months. A Tees Valley policy comparison table on the DVLA licence requirement of new applicants is attached as Appendix 2.

- 6. The response to the consultation from the trade was highly in favour of this policy change.
- 7. No quantifiable data is available on driving experience. A driver could for example have held a DVLA licence for three years and not driven a vehicle during this time. It is perhaps assumed in some cases experience comes with age. Data supplied by the Tees Valley Authorities show the current numbers of drivers 21 years or younger, is low. Indicating the Private Hire or Hackney Carriage profession does not attract young drivers.

- 8. The twelve North East Local Authorities hold a register on driver licence refusals / revocations and suspensions. Since November 2017 304 drivers have been added to this register, 6 of those were born in 1995 or before (24 years) at the time they were refused or revoked. Although this is not a comparison of driving experience data, it is an indication of the numbers of drivers under the age of 24 being refused / revoked or suspended in the North East.
- 9. Members should note all new applicants have to complete and pass the Tees Valley Taxi Driving Assessment before a licence is granted, which is a written and practical advanced driving assessment.
- 10. Members should also note there has been a reduction in the number of new driver application received by the authority, the table below shows data of new applications received.

11. In light of the above additional information and to ensure a level playing field across the Tees Valley, it is proposed that Cabinet consider recommending to Council reducing the requirements for new applicants to have held a full DVLA licence to 12 months, rather than the current policy requirement of three years.

#### 12. Vehicle Specification

Currently this authority will not licence any category of insurance write off vehicles. The trade have requested the current policy is amended to licence these vehicles, which can be licensed with other neighbouring and wider local authorities.

- 13. Due to the Deregulation Act 2015 Stockton licensed Private Hire Operators can subcontract work to other operators, vehicles and drivers licensed with other authorities. These vehicles and drivers are currently operating within the Borough, but are out of the control of this authority.
- 14. For the purposes of clarity an insurance write-off means a vehicle that has either sustained a level of damage that deems it unsafe to go back on the road, or it remains safe to drive but is beyond economical repair. The insurance write off categories are:

Cat A - Scrap only. For vehicle so badly damaged they should be crushed and even salvageable parts must be destroyed

Cat B - Body shell should be crushed. Signifies extensive damage, although some parts are salvageable.

Cat S (was C) - The vehicle has suffered structural damage. This could include a bent or twisted chassis, or a crumple zone that has collapsed in a crash and the vehicle will need to be professionally repaired, it won't be safe to drive until repairs have been completed.

Cat N (was D) - Vehicles have not sustained structural damage to the frame or chassis, the issue may have been cosmetic, however it is not economical to repair. Examples may include lights, infotainment, electrics or even heated seats.

- 15. In comparing other Tees Valley authorities:
  - Darlington have a policy in line with Stockton but are currently considering reviewing it to allow C/S, and D/N.
  - Hartlepool and Redcar allow categories C/S, and D/N vehicles with a compliance test at their own testing station.
  - Middlesbrough allow C/S and D/N vehicles but require an engineer's report and in some cases a JIG report as well as a compliance inspection at their own depot.
  - A Tees Valley policy comparison table on vehicle specification is attached as Appendix 3.
- 16. This authority encourages modern vehicles in a bid to improve the licensed fleet and improve air quality. From the 1 January 2020 an age restriction policy will be introduced for all private hire and hackney carriage saloon vehicles. Applications will only be considered if the vehicle is no older than five years from the date of first registration. Any renewal of an existing private hire or hackney carriage saloon vehicle will only be granted if the vehicle does not exceed the maximum age limit of twelve years.
- 17. The increased complexity of modern cars, mean more cars are being classed as insurance write off categories despite not being very old due to the increased costs of repairing them, resulting in some vehicles remaining safe and suitable being wrote off as a result of the insurance company stated costs of repair.
- 18. The response to the consultation from the trade was highly in favour of this policy change.
- 19. In light of the above additional information and to ensure a more level playing field across the Tees Valley it is proposed Cabinet consider recommending to Council to allow insurance category D/N vehicles to be licensed.

#### 20. Tinted Windows Specification

The trade have requested the current specification on tinted windows is amended to reflect factory fitted tints which come as standard in most modern vehicles. Currently this authority require light transmission of 75% in the vehicle windscreen and 70% in all other windows.

- 21. In comparing other Tees Valley authorities:
  - Darlington have a policy in line with Stockton.
  - Middlesbrough require light transmission of 75% in the windscreen, 70% in the front windows and 30% in rear windows.
  - Hartlepool require light transmission of 75% in the windscreen, 70% in the front windows and 30% in rear windows.
  - Redcar require light transmission of 75% in the windscreen, 70% in the front windows and 34% in rear windows.
  - A Tees Valley policy comparison table on tinted windows in vehicles is attached as Appendix 4.
- 22. The response to the consultation from the trade was highly in favour of this policy change.

- 23. In light of the above additional information and to ensure a more level playing field across the Tees Valley it is proposed Cabinet consider recommending to Council that we allow vehicles to have standard factory fitted tinted windows.
- 24. Next Steps summary of the consultation with the trade and licensing committee will be considered by Cabinet on 14 November 2019 and full Council on 20 November 2019. Following approval any changes agreed would come in to immediate effect.
- 25. The trade will be informed of decisions via emails to private hire operators and the SHCDA, via the trade Facebook page and via the website. In addition the requests and decisions will be added to the agenda at the next trade meeting on 5 December 2019.
