Family Weight Management Service

The Partnership received a presentation from the providers of the Family Weight Management Service.

Members noted the sensitivities associated with this service and the difficulties this presented to health, education and other professional.in terms of raising issues of obesity with Families. The Partnership agreed that awareness of the service/referral process could be improved and a number of actions were agreed to try and achieve this.

The Partnership will receive details of the outcomes of the Hartlepool Inspection at a future meeting.

Childhood Obesity Strategy - A Plan for Action

Members received an overview report of the recently published government document entitled 'Childhood Obesity: A Plan For Action'. The plan identified that further work would need to be undertaken at a local, regional and national level to achieve a reduction in England's childhood obesity levels by 2026

There was discussion about work in Stockton and, in particular, The Phunky Foods programme, which encouraged schools to meet the voluntary school food standard. It was agreed that this was an important programme and needed to be promoted. Following the meeting the Director of Children's Services wrote to schools, and other services, highlighting the programme and the Family Weight Management Service.
