HEALTH AND WELLBEING UPDATE

SUMMARY

In accordance with previous decisions made by the Board this report provides a brief overview of discussions at the Adults Health and Wellbeing Partnership and Children and Young People's Partnership. The report also provides the minutes of meetings associated with the Health and Wellbeing Structure and asks the Board to agree some changes to the memberships of the Joint Commissioning Groups and note some amendments to Partnership memberships.

Health of the Homeless Update.

There was lengthy discussion on the Health of the Homeless and the work of a multi partner working group that had been established to look at ways of helping this vulnerable group. There was particular discussion around the mental health of homeless people and links with drug and alcohol abuse. It had been agreed that TEWV would provide an update on dual diagnosis to the Partnership's March meeting.

Community Health Ambassadors – Health Service Survey

The Partnership received an overview report that provided an overview of the themes and findings from the Health Services Survey, carried out by Community Health Ambassadors.

The survey had provided a great deal of useful material and participants had indicated that they were keen to engage in similar engagement sessions in the future. The survey had led to a number of participants expressing an interest in becoming a Community Health Ambassador.

Partners had noted that the survey had only included one question around mental health and a significant number of participants had skipped that question. Partners had suggested that this needed to be considered further and picked up for any future surveys.

School Performance

Partners received a report on performance of vulnerable pupils.

During consideration of this report reference was made to the importance of reading to children every day and partners were asked to consider how they could contribute to encouraging this. Subsequently, a specific item had been placed on the Partnerships February meeting, when this would be further considered.

Consideration of this raised a number of issues including: The gap between the labour market and education system and a need to improve engagement with employers. The Partnership noted that work was ongoing in this area and asked for further updates to future meetings.
