REPORT OF PARTNERSHIP CHAIRS.

HEALTH AND WELLBEING UPDATE

SUMMARY

This report provides a brief overview of discussions at meetings associated with work undertaken by the Adults Health and Wellbeing Partnership and the Children and Young People's Partnership.

Members will be aware that meetings of the Partnerships have moved from a monthly to a bi-monthly frequency. As the Partnerships' September meetings were stood down, the minutes of the June/July meetings were only approved at the November meetings and this is the reason for the delay in them being presented to the Board for information and noting.

DETAIL

Children and Young People's Partnership – 19 June 2019 - Appendix 1

Conduct Disorder

1. The Partnership received presentations from TEWV, relating to Conduct Disorder and the interventions available, locally. The Partnership noted the prevalence of behavioural difficulties in children, assessed in Stockton on Tees. It was noted that, in the most complex cases, Multi- Systemic Therapy had been successful, which involved working with, and wrapping services around the whole family.

Youth United Stockton

2. Members received a presentation relating to Youth United Stockton, which was a consortium that had been commissioned to deliver open access youth provision, across the Borough. Members supported the delivery model and recognised that it could be used in other areas.

Local Maternity System

3. The Partnership received a presentation on Continuity of Care which looked to identify a named midwife who took responsibility for coordinating a woman and her Baby's care throughout her pregnancy, delivery and postnatal period.

JSNA

4. The Partnership signed off the Domestic Abuse and Armed Forces JSNAs.

5. Catalyst was in attendance to provide a presentation on the LWBC programme.
