### **H        Draft Minutes - 10th January 2011**

CONCLUDED that the draft minutes of 10th January 2011 were agreed as a correct.

### **H        Action Plan for Agreed Recommendations - EIT Review of Fair Access to Care**

Members were requested to consider the Action Plans setting out how the agreed recommendations from the Efficiency Improvement and Transformation (EIT) Review Fair Access to Care would be implemented and target dates for completion.

The Officer's final report of the EIT Review of Fair Access to Care was considered by Cabinet on 25th November 2010. Cabinet accepted the recommendations contained within.

These recommendations were now subject to the procedure for monitoring the implementation of agreed recommendations. An Action Plan had been drawn up and was provided for members consideration.

It was requested that Members be updated prior to further communication with residents and clients, and any other significant actions when implementing the recommendations.

Members discussed support to voluntary and community sector organisations, and were informed that a further EIT review was planned to examine grants to organisations supporting independent living and carers.

CONCLUDED that the Action Plan be approved.

### **H        EIT Task and Finish Review of Adult Service Structures 56/10 - baseline presentation**

Members were provided with a presentation in relation to the EIT Task and Finish Review of Adult Service Structures.

It was proposed that the baseline information be presented at this meeting and the recommended options for the review be presented at the meeting on 8 March, 2011. It was noted that the report to be considered on 8 March would contain the principles that would be used to inform the future configuration of the service structure.

Members were provided with a briefing note on relevant legislation and a copy of the current Adult Strategy Service structures.

There had been a number of recent and proposed changes in relation to the structure of local adult social care and health services. The PCT had also changed their structure in December 2010. North Tees and Hartlepool Foundation Trust had withdrawn financial support for joint management arrangements and it was anticipated that the PCT would also be withdrawing their funding by the end of this financial year. Discussions were also ongoing in relation to the posts that were jointly managed by Tees, Esk and Wear Valley Foundation Trust. In addition, there have also been a number of changes in health policies by the new Government. This has resulted in there being a need to review the structure for Adult Services.

Initial consultation had began with staff and Unions and they had been asked to submit any ideas/suggestions for improvement.

CONCLUDED that the information received be noted and that an options report be received on 8th March 2011.
