This has resulted in maintaining more staff at work OR returning them to work as soon as possible.

In order to maintain the high standards of care Body 2 Fit offers and SBC expects, all of our staff meet regularly to audit data, peer review client cases, critique the literature on practice to ensure evidenced based practice and subsequently discuss how to further improve our service.
