2	Minutes Consideration was given to the minutes from the meeting held on 25 January 2021. AGREED that the minutes be approved as a correct record and signed by the Chair.
3	Overview Reports Members were presented with overview reports from the following directorates: <ul style="list-style-type: none">- The Environment, Culture, Leisure and Events- Xentrall Shared Services- HR, Legal and Communications- Finance, Development and Business Services- Administration, Democratic and Electoral Services All the overview reports reflected on the challenges and opportunities and the priorities for the year ahead. The main issues from the overview report for The Environment, Culture, Leisure and Events were as follows: <ul style="list-style-type: none">• Members welcomed the new Business and Intellectual Property Centre. Members were informed that most of the information would be accessible online, however, attempts would be made to make advice and guidance available across the Borough.

	<ul style="list-style-type: none"> • Members questioned when work on the public toilets in Preston Park would begin. Members were informed that although an exact date had not been confirmed, work should commence within weeks. This would be a short-term improvement but there were also hopes for a long-term renovation to make these toilets more accessible. This was dependent on funding. • The significance of the Spence Collection at Preston Park Museum was noted, and Members were enthused about the prospect of the collection receiving wider recognition and funding. • Members thanked the teams for their work during the pandemic <p>The main issues from the overview report for Xentrall Shared Services were as follows:</p> <ul style="list-style-type: none"> • Members commended IT staff for their support throughout the pandemic, for rapid responses to issues with equipment, and for providing necessary information. <p>The main issues from the overview report for HR, Legal and Communications were as follows:</p> <ul style="list-style-type: none"> • Members commented on the number of younger staff who were not members of the pension scheme and stressed the importance of paying into a pension scheme. • Members thanked the teams for their continual assistance in providing up to date information to residents, Members, and staff, and for effectively communicating key information from central government across platforms. <p>The main issues from the overview report for Finance, Development and Business Services were as follows:</p> <ul style="list-style-type: none"> • Members recognised the spending reductions from central government and thanked staff for their ongoing support to residents and businesses during the pandemic.
