# Review of Disability Inclusive Borough Progress to date

Q&A from Session 1 Q1

Members questioned what had happened to the Ayresome Industries building, a school for the blind in Middlesbrough, and what had replaced this service. Officers agreed to provide Members with an answer to this query.

MBC recently completed the sale of the Ayresome Industries premises (on 19<sup>th</sup> November 2020). The window frame and brush making by the disabled workforce ended prior to this and the building was then used as an operational Council depot before it was declared surplus and marketed for sale.

The school for the blind on Stockton Road was demolished many years ago as the building had been unused for a long time and had fallen into a dilapidated condition. They have relocated in the building next door and are operating under the Teesside & District Society for the Blind. They have a website <u>www.teessideblind.co.uk</u>

Q&A from Session 1 Q2

Members questioned if the outcomes of a previous study, based on the use of pictorial messages to assist people with learning difficulties, had been implemented. Officers agreed to provide Members with an answer to this query.

Both Adults & Children's Services are part of the revised Officer working group for this review and have been asked to explore this during the gathering of information for the key lines of enquiry.



## Review of Disability Inclusive Borough Progress to date

#### Q&A from Session 1 Q3 – John Angus

Members discussed the difficulties that some residents faced travelling on pavements in wheelchairs due to a lack of dropped kerbs in some areas

On occasion, residents had asked Members if dropped kerbs could be purchased through the Community Participation Budget (CPB).

Members questioned if a mapping exercise of dropped kerbs could be conducted as part of this review.

Members asked if registered providers of social housing could be encouraged to make housing more 'user-friendly'. For example, through the widening of doors and paths.

#### Building Regulations 2010 (2015 amended) Approved Document M (Vol.1) Access to and Use of Buildings

Category 1 – <u>Visitable dwellings</u>. Category 2 – <u>Accessible and adaptable dwellings</u>. Category 3 – <u>Wheelchair user dwellings</u>.

Category 1 – <u>Visitable dwellings</u>. <u>Compliance</u> with this requirement is achieved when a new <u>dwelling</u> makes reasonable provision for most people, which includes <u>wheelchair users</u> to <u>access</u> and enter the <u>dwelling</u>, and <u>access habitable rooms</u> and <u>sanitary facilities</u> on the <u>entrance level</u>.

Category 2 – <u>Accessible and adaptable dwellings</u>. This requirement is met when a new <u>dwelling</u> provides reasonable provision for most people to <u>access</u> the <u>dwelling</u> and includes features that make it suitable for a range of potential <u>occupants</u>, including <u>older people</u>, individuals with reduced mobility and some <u>wheelchair users</u>. Category 3 – <u>Wheelchair user dwellings</u>. This requirement is achieved when a new <u>dwelling</u> provides reasonable provisions for a <u>wheelchair user</u> to live in the <u>dwelling</u> and have the ability to use any <u>outdoor space</u>, <u>parking</u> and communal <u>facilities</u>.

Requirements Category 2 and Category 3 are 'Optional Requirements' as defined in the Building Regulations. An Optional Requirement only applies where a condition that one or more dwellings should meet the relevant Optional Requirement is imposed on new development as part of the process of granting a planning permission. Where no condition is imposed, dwellings only need to meet the requirements of M4(1). Compliance should only be assessed against one of the Requirements for any given dwelling.

SBC standards from The Local Plan:-50% Category 2 8% Category 3
