28/22**      **Monitoring the Impact of Previously Agreed Recommendations - Progress report for the previously completed Local Government Pension Scheme (LGPS) Task and Finish review.**

The Select Committee considered a progress update including assessments of progress following implementation of the recommendations from the Local Government Pension Scheme (LGPS) review. The overall aim of the review had been to understand the causes of the fall in LGPS membership so that, as far as possible, any issues could be addressed, and the workforce encouraged to put in place suitable pension arrangements. This was the first time the update had been presented to the Committee. There were five outstanding recommendations.

The Committee requested the following further information:

- Reasons for the lower take-up of the Local Government Pension Scheme (LGPS) within Stockton-on-Tees Borough Council's (SBC) Children's Services.

AGREED that:

- 1) the Progress Update be noted and the assessments of progress be confirmed.
- 2) the further information be provided as requested.

**PEO 29/22 Monitoring the Impact of Previously Agreed Recommendations - Progress report for the previously completed Disability Inclusive Borough review**

The Select Committee considered a progress update including assessments of progress following implementation of the recommendations from the Disability Inclusive Borough review. The overall aim of the review had been to explore how Stockton-on-Tees Borough Council could contribute to a more disability inclusive borough. This was the first time the update had been presented to the Committee. There were 13 outstanding recommendations.

The Committee requested the following further information:

- Members to have access to the online disability training modules for information purposes.
- Confirm if local businesses were aware that British Sign Language posters and cards were available to collect from Customer Services Centres.
- Investigate if yellow paint could be applied to older dropped kerbs to assist those with visual impairments.

AGREED that:

- 1) the Progress Update be noted and the assessments of progress be confirmed.
- 2) the further information be provided as requested.

**PEO 30/22 Scrutiny Review of Home Energy Efficiency and Green Jobs for the Future**
