	<p>Scrutiny Review of Review of Burial Provision – Action Plan for Agreed Recommendations</p> <p>The Select Committee were presented with the Action Plan setting out how the agreed recommendations from the Review of Burial Provision would be implemented and target dates for completion.</p> <ul style="list-style-type: none"> • A new burial site for the central or western areas of the Borough • That officers undertake further surveys and investigations of potential burial sites to determine suitability • A consideration for an additional smaller burial site in the south of the Borough. Officers to consult with Ward members and Parish Councils to determine how this could be facilitated. <p>AGREED that the Action Plan be approved.</p>
	<p>Monitoring the Impact of Previously Agreed Recommendations - Scrutiny Review of Review of Consolidation of Thirteen Housing Group–Progress Update</p> <p>The Select Committee considered a progress update including assessments of progress following implementation of the recommendations from the Review of Consolidation of Thirteen Housing Group.</p> <ul style="list-style-type: none"> • Members were pleased with the progress of Thirteen Housing Group review and praised officers for their work. <p>AGREED that: Recommendations are fully achieved.</p>

	<p>Monitoring the Impact of Previously Agreed Recommendations - Scrutiny Review of Asylum Seekers Servicers – Progress Update</p> <p>The Select Committee considered a progress update including assessments of progress following implementation of the recommendations from the Review of Asylum Seekers Servicers.</p> <ul style="list-style-type: none"> • The contract for asylum seeker dispersal accommodation is the Home Offices, the new contract (in place since 2019) was awarded to Mears, since this time Mears have operated no room sharing for asylum seekers coming into the borough. • The Home Office contract does allow room sharing, however as noted Mears do not currently operate Asylum Seekers room sharing. • Members were pleased with the outcome of no room sharing within the borough. <p>AGREED that:</p> <p>1) the Progress Update be noted and the assessments of progress be confirmed fully achieved.</p>
	<p>Scrutiny Review of Highways Asset Management (inc. Potholes & Flooding)</p> <p>The Select Committee received a presentation regarding the following Key Lines of Enquiry from the review scope:</p> <ul style="list-style-type: none"> • How is funding allocated for highways infrastructure asset management? How has this funding changed over previous years? What is the projected condition of the highway if the budget remains the same over the next five years? • What could be done if SBC were provided with additional funding to repair/maintain highway infrastructure assets?
