

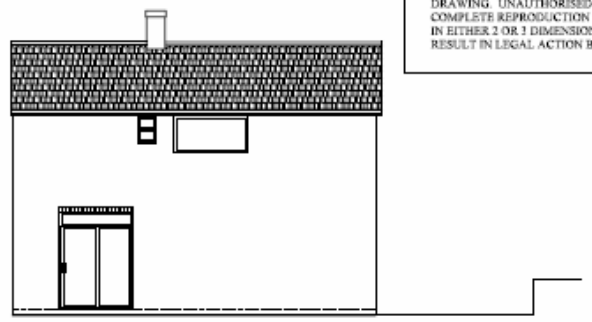

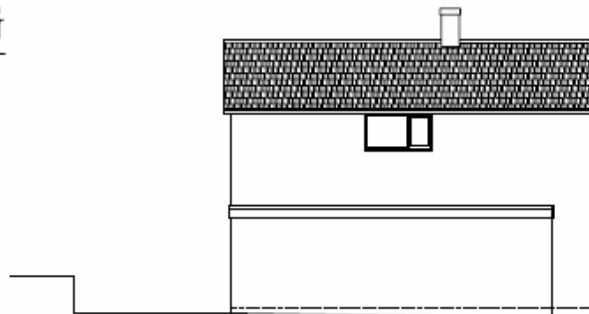

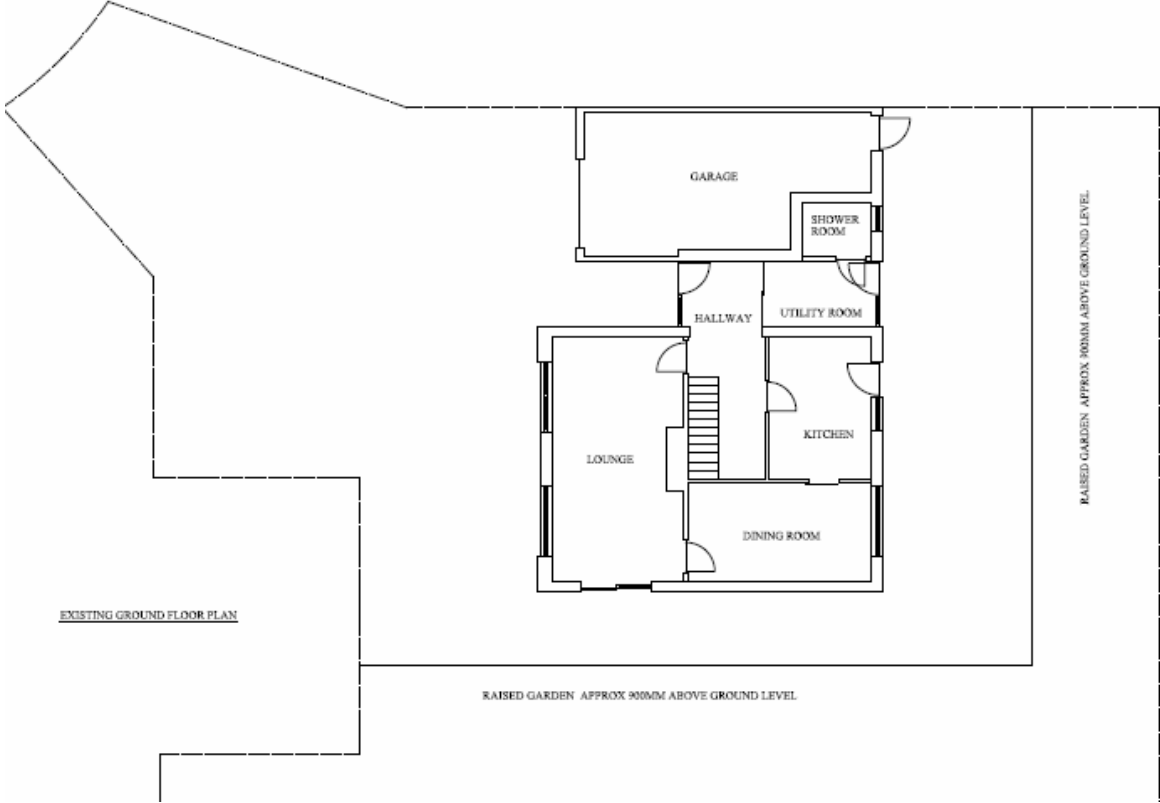
EXISTING REAR ELEVATION

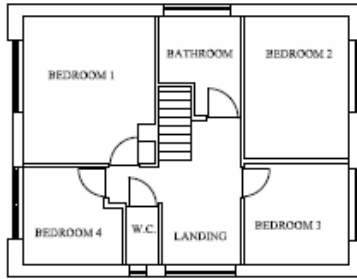

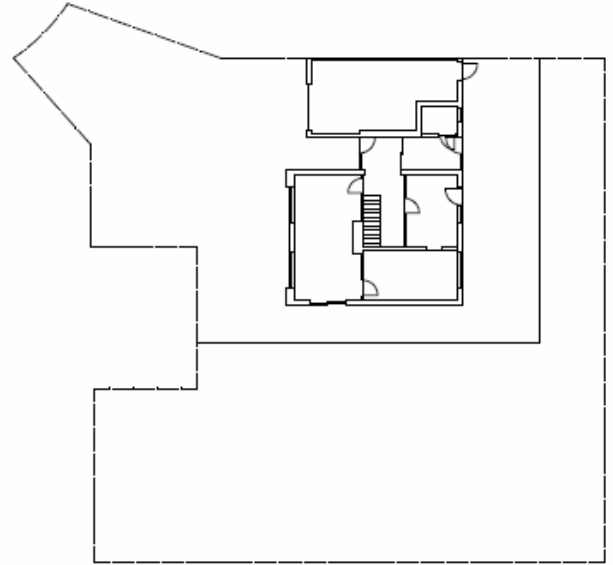

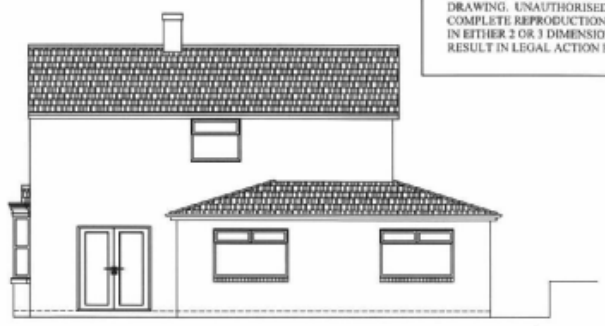

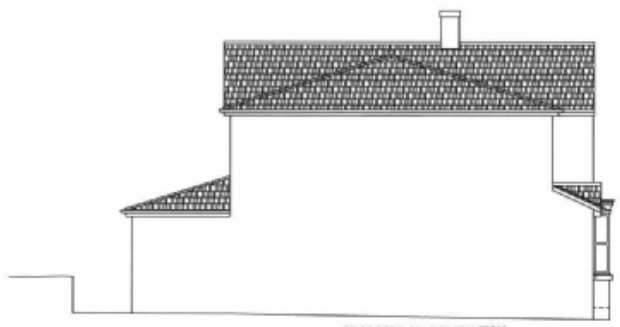

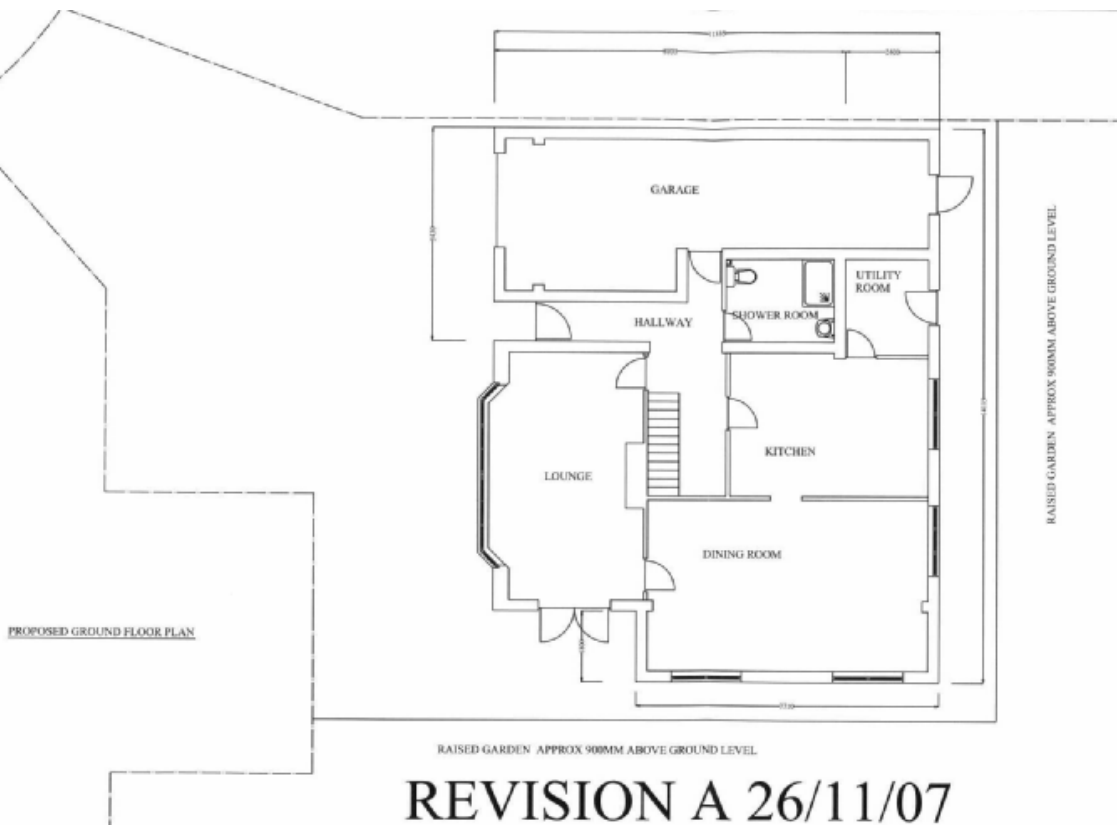


PROPOSED REAR ELEVATION

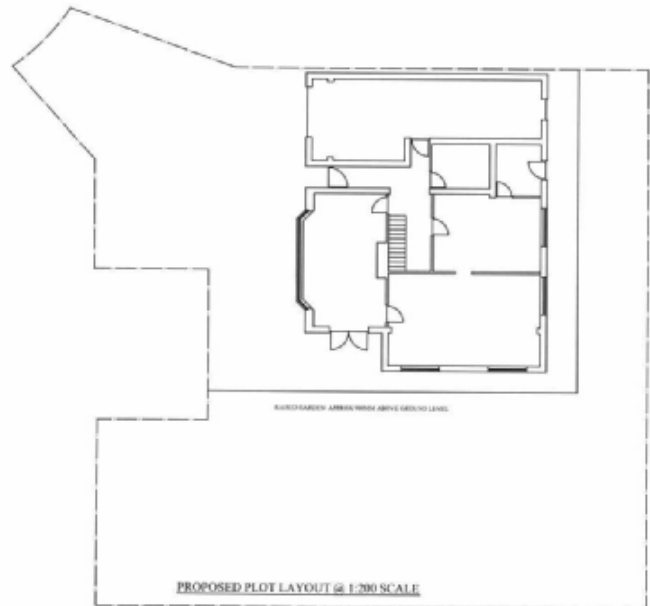
