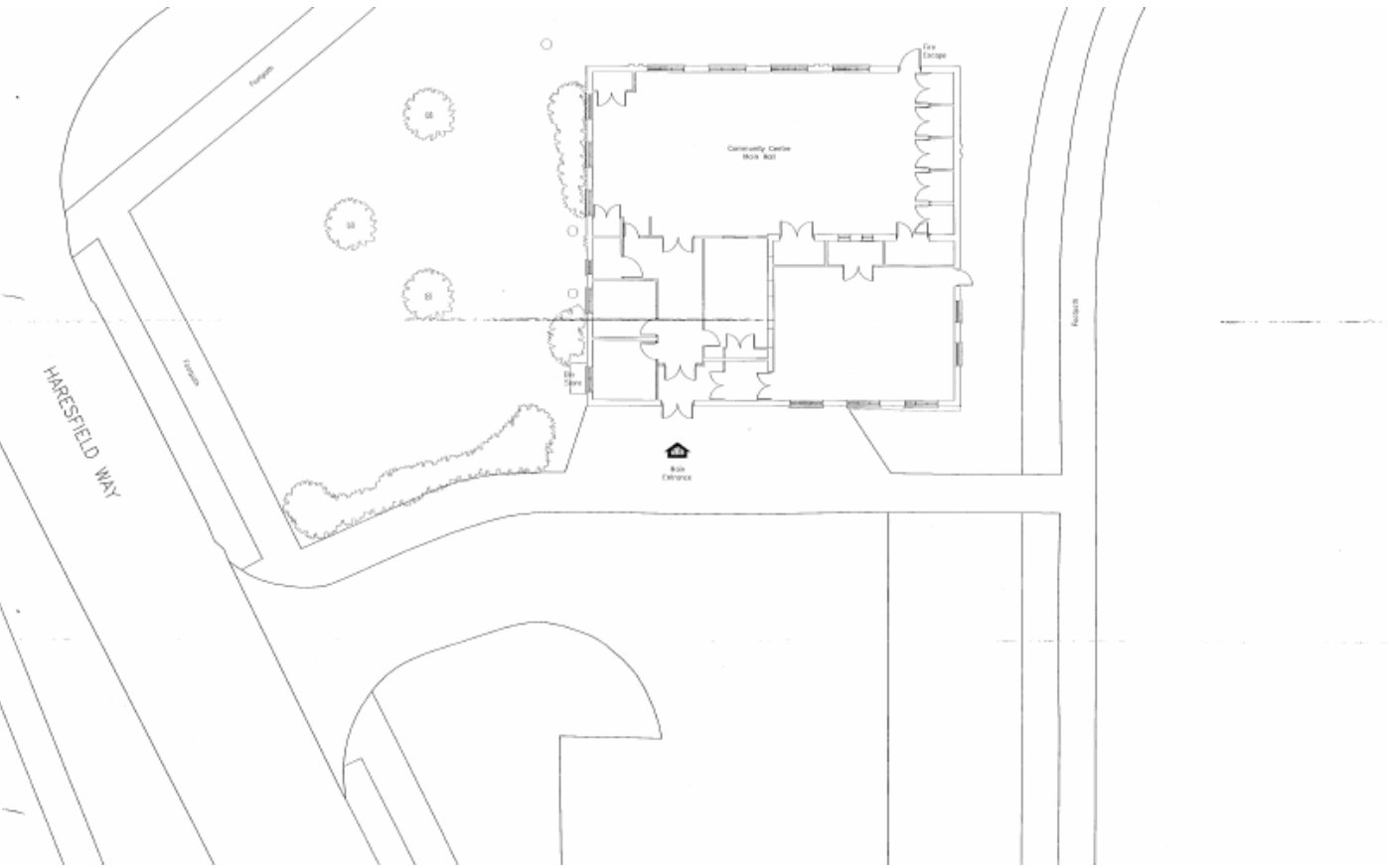

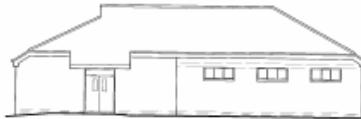
Existing South-East Elevation

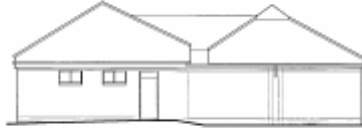

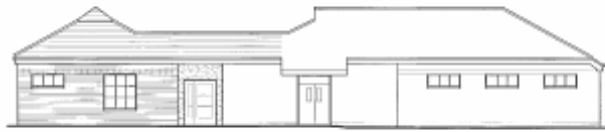
Proposed South-East Elevation
