SUMMARY

CONSULTATIONS

1. The following Consultations responses have been received:-

Regeneration and Economic Development

Regeneration & Economic Development would be concerned about the impact this out of town centre mixed use (restaurant & banqueting suite) proposal could have on town centre vitality. A sequential test would need to be carried out to assess whether any alternative town centre units could suitably accommodate the proposed development.

PUBLICITY

2. Neighbours were notified and a total 2 letters of support have been received, these are set out below :-

Mr Ali Sadiq (Price Right Properties) - 12 Lambeth Road, Middlesbrough

This is a letter of support for the change of use for this property. I feel this area is in great need of an A3 restaurant and banqueting venue. More support should be given to these kinds of projects as it makes derelict buildings useful and not getting vandalised. We have recently purchased a property on Skinner Street and our tenants are in favour of this planning.

Pro-forma letter (20 Signatories)

I support the planning application. It will bring back into use a vacant building and enhance Stockton Town Centre as a whole, by bringing customers from all over the borough and wider areas, as there is no wedding facility for multicultural use since the closure of Tall Trees and Coatham Bowl. Recently users of such venues have been travelling far afield to Durham and South Shields. I would like the application to be approved and support it for the future of Stockton.
