UPDATE REPORT

Since the issue of the main report additional comments have been received and are considered as follows:

Additional comments of support from Mrs Carolynn O'Donnell of 16 St Davids Grove, Ingleby Barwick are detailed below:

"As a mother of a severely autistic child I fully support this proposal and find some of the objections highly offensive and blatantly discriminatory. Surely as a community we should applaud and support a facility that helps vulnerable disabled children - not shun it. These children are no more a threat to society than any other child living in Aislaby Road, they just need someone to give them help and support perhaps some of the residents who have objected should read up on autism before being so cruelly judgemental."

A comment of objection not addressed within the main report was received from James Shearer of Highfield Manor Aislaby Road as below:

"There are toxic plants such as hog weed along Aislaby Road, therefore the site should be deemed an unsafe environment for disabled children."

Material Planning Considerations

The additional comments of support are noted and does not alter the recommendation of the main report.

The comments relating to the presence of any poisonous vegetation external to the site are considered to be a circumstance of any publicly accessible environment where a number of hazards may exist and would not raise a level of concern that would prevent the use from operating at the application site to warrant a reason for refusal of the planning application. It is considered that external hazards of this nature would fall to the responsibility of individuals.

CONCLUSION

The recommendation of the main report remains unchanged, which is that the application be approved with conditions along with the appropriate conditions as set out in the officer report.
