UPDATE REPORT

Following the publication of the Agenda there has been further discussions with the Applicant over the servicing of the proposed store and the access arrangement. As a result of these discussions the applicant has made some minor changes to the access, the revised access plan has been appendixed to this report. The changes include the increased width of the access road with the provision of a pedestrian island.

Condition 06 has therefore been revised to take into account the revision to the access. The proposed wording of Condition 06 is set out below.

Condition 06

Service Management Plan

Within each phase, no development shall take place, until a Servicing Management Plan has been submitted to, and approved in writing by, the Local Planning Authority. The Servicing Management Plan shall provide details of:

- A carpark management plan;
- Details of vehicle type, size, frequency of all service vehicles;
- Once operational servicing times of all HGV's shall be restricted to 7.00-7.45 and 18.00-23.00 hours, unless it has been satisfactorily demonstrated to the Local Planning Authority that alternative delivery times do not adversely affect highway users.
- Details of all offsite waiting areas where vehicles can stack off the adopted highway waiting to be called to the loading bay.

Reason. In the interests of highway safety and the general amenity of the area.
