loading or unloading but this must be carried out in such a way that it will not obstruct the passage of emergency vehicles. Any vehicle parked for the purpose of loading or unloading shall not be left unattended at any time.

The contractor must contact Stockton Council Highways Dept. to agree any highway or footpath crossovers prior to work commencing. All areas to be made good on completion.

<u>Deliveries</u> Under no circumstances will deliveries of any materials or plant be permitted between the hours of 7.45 - 9.15am and 2.45 - 3.45pm on weekdays throughout the duration of the works. No vehicles are to be moved within the site at playtimes i.e. between the hours of 10.30 - 10.45am, 12.05 - 1.00pm and 2.15 - 2.25pm (these times to be confirmed).

<u>Skips</u> The skips must be of the covered lockable type, which shall remain locked at all times except when depositing waste. All skips labelled accordingly with contractor details.

throughout the duration of the works. The facilities must be locked within the designated site compound as indicated on the site plan. <u>Toilets (in accordance with Schedule 2 of the CDM Regulations)</u>
The contractor must provide their own toilet facilities throughout the duration of the works. The facilities must be locked within the designated site compound as indicated on the site plan. The contractor shall clean the toilet facilities on a weekly basis, removing all rubbish and debris in the process. On completion of the works, the contractor shall thoroughly clean the toilet facilities, remove all rubbish and debris and reinstate them to its original condition. All damage shall be repaired and, if necessary, the toilet facilities shall all be redecorated to the entire satisfaction of the CA.The contractor shall not, under any circumstances, be permitted to use any other toilets situated around the building or any of the schools toilet facilities. This requirement shall be rigorously enforced.

over. The fence may be constructed from weldmesh panels, Heras panels or chipboard. This shall maintained in good and effective condition until the work is completed. Fencing to be located as shown, and only removed at completion of main works to allow soft landscaping to be undertaken. No materials may be stored within the root protection area of the tree. No materials should be allowed to contaminate the ground within the root spread of the tree. Trees should not be used as anchorages for equipment or for other purposes.

GENERAL NOTES
Contractor must form any temporary crossovers to existing footpaths, verges and fencing around the site boundary as required to gain access to the works. All these should be made good, back to original condition at completion of the works. Contractor to remove any asbestos as required prior to commencing any works in the individual areas. Existing grassed and paved areas must be adequately protected prior to any pedestrian or vehicular traffic. Any damage is to be repaired by the main contractor upon completion. Fire exits in existing and proposed school areas must be maintained at all times.
