1.2	Stay out of worst Quartile for the following two years	At the end of June 2007 we were ranked at 98th out of 371. This is a drop in performance by 7 places since February 2007. GONE has confirmed that all but 3 CDRP's in the region have also seen a drop in the rankings. We have also seen a reduction in our performance measured by iQuanta. We are currently 8th out of 15 MSCDRP's (Apr - Jun 07). We were consistently 4th throughout 2006/07 so have dropped 4 places.	😊	Latest update available is for August and Stockton was ranked 95th out of 371. This is a further drop in performance of 3 places and puts us only 2 places outside the worst quartile. We have seen an improvement in our ranking on iQuanta since last quarter. We are 5th out of 15 MSCDRP's (Jun - Aug 07). This is more on a par with our performance last year where we were consistently 4th.	😊	Latest update available is for November and Stockton was ranked 94th out of 371. This is a drop in performance of 1 place and now only 1 above the worst quartile. At the end of December 2007 we were 6th out of 15. This is a drop in performance on Q2, but still below group average.	😊	Latest update available is for March and Stockton was ranked 89th out of 371. This is a drop in performance of 4 places and now in the worst quartile. At the end of March 2008 we were 6th out of 15. This is a further drop in performance on Q3, but still just below group average. Disappointing that this happened in the final quarter within life of the Plan and should be noted that this depends on performance of other Partnerships, and although we have not performed badly it appears other Partnerships have performed better!	😞
1.3	Reduce Total recorded crime by 20% from 2003/04 baseline of 20,534 2005/06 – 17,865 (87%) 2006/07 – 17,043 (83%) 2007/08 – 16,427 (80%)	There were 4,675 offences recorded in Q1. This is an increase of 4.5% on the same period last year. This means we are performing at 13.8% above our target for this year. At the end of 2006/07 we had seen a reduction of 14% on the 2003/04 baseline. This has reduced to a 8.9% reduction based on Q1 figures. The greatest increases in crime have been for Other Theft (264 offences) and Violent Crime (101 offences)	😞	There were 4,191 offences recorded in Q1 & 8,867 YTD. This is an increase of 1.8% on the same period last year and means we are performing at 7.9% above our target for this year. The reduction on the 2003/04 baseline now stands at 13.6%, so this is an improvement on last quarter but still short of the targets	😞	There were 4,429 in Q3, this is a 2.3% reduction for the same period last year, and 13,298 YTD. However we are still 7.9% above our target for this year. The reduction on 2003/04 baseline remains at 13.6% with the biggest increases this quarter being for Other Theft and Other Crime.	😞	There were 4,355 in Q4 and 17,653 in total for the financial year with a 0.1% reduction on figures from last year. However the target has not been achieved and is 7.5% above set target. The biggest increase this year have been for Other Theft which has impeded our performance in reaching the target.	😞
