NI15 Most Serious Violent Crime

There have been <u>82</u> MSV crimes between April 2009 to February 2010 (0.43 per 1,000 population), which is an increase of 2 offences (2.5%) on the same period last year.

Of the 82 crimes there were two Murders, 1 Attempted Murder, 1 causing death by careless driving, 31 Wounding and other acts endangering life and 47 Grievous Bodily Harm without intent.
