

JSNA – Alcohol - Recommendations

2012/01

Reduce alcohol related harm to Young people, families and communities, through the delivery of sustained and consistent messages around alcohol consumption, in order to influence attitudinal change and create a cultural shift.

2012/02

Reduce the number of alcohol related hospital attendances and admissions.

2012/03

Deliver treatment services which are evidenced-based, cost effective and are responsive to and accessible for all individuals who require treatment

2012/04

Target offenders of alcohol related crime, with a focus upon violent crime, anti-social behaviour and domestic violence.

2012/05

Enable frontline staff to identify early problematic alcohol use, provide brief interventions and make appropriate referrals

2012/06

Reduce the availability of alcohol with a particular focus on sales to young people.

JSNA – Drugs - Recommendations

2012/01

To ensure that the four principles for commissioning a drug treatment system that promotes successful recovery journeys are thoroughly embedded across the Stockton partnership. These four principles are:

1. Recovery is initiated by maintaining, and where necessary improving access to early and preventative interventions, and to treatment
2. Treatment is recovery orientated, effective, high-quality and effective
3. Treatment delivers continued benefit and achieves appropriate recovery-orientated outcomes, including successful completions
4. Treatment supports people to achieve sustained recovery

2012/02

That all strategies and services continue to develop an outcome based focus in-line with the outcomes described in the HM Government Drug Strategy 2010

JSNA Health of Offenders - Recommendations

2012/01

To ensure that the Mental Health needs of offenders are identified and supported

2012/02

To ensure that the Learning Difficulties and/or Disabilities of offenders are identified and supported

2012/03

To ensure across the prison and community services that effective interventions take place with regard to blood borne viruses

2012/04

That all drug-related strategies and services continue to develop an outcome based focus in-line with the outcomes described in the HM Government Drug Strategy 2010

2012/05

To ensure that the unique needs of female offenders are identified and supported

2012/06

To ensure that pathways into suitable and sustainable accommodation and employment continue to be developed and supported

2012/07

To ensure that the needs of children of offenders are supported, giving particular reference to the following principals:

- Wherever possible, the trauma experienced by children during the arrest of a family member(s) should be minimised
- Where possible, parents should be placed in a prison near to their family base with an appropriate level of visits allowed
- Specialist support (especially mental health) for children who have parents in contact with the Criminal Justice System should be provided

2012/08

To maintain investment in Offender Health Trainer interventions

JSNA Domestic Violence – Recommendations

2012/01

Research the costs of domestic violence to the NHS in Stockton-on-Tees, looking at particularly at A&E episodes and GP contacts.

2012/02

Pilot an Integrated Offender Management approach to tackling Domestic Violence working with 10 families with a view to reducing the impact/frequency of health services as a result of intervention

2012/03

Provide focussed support work in a 1:1 and group setting for individuals with substance misuse issues

2012/04

Explore the feasibility of utilising specialist workers to work to support 'hard to reach' groups such as individuals with special needs and male victims

2012/05

Improve the training and awareness of health professionals such as G.P's, A and E staff, midwives and health visitors in relation to domestic violence.

2012/06

Agree future IDVA arrangements for Stockton

JSNA Crime and ASB - Recommendations

2012/01

Extend the emerging issues priority to include all acquisitive crime not just Other Theft. Main issue seems to be metal thefts, which is also impacting upon burglaries where metal is targeted, but other categories of acquisitive crime seem to be on the increase.

2012/02

Assess all current targets within the Community Safety Plan and re-set for 2012-13.

2012/03

Look at first time offenders and try to establish their motivation for offending. Explore the possibility of a pilot study to question first time offenders in custody, especially those receiving drug tests when arrested for trigger offences.

2012/04

Prioritise offenders committing burglary offences as they have the highest rate of repeat offending.

2012/05

Explore possible reasons for the changes to crime and deprivation levels within Parkfield and Oxbridge ward.

2012/06

Re-establish and agree the terms of reference for the Drugs 'Reducing Supply' Group

2012/07

Seek to raise the profile of alcohol and assess the role of all current alcohol related working groups as well as current procedures to ensure that nothing is being missed.

2012/08

Ensure that Domestic Violence services are well publicised across the Borough, especially in more affluent wards / neighbourhoods where services are not currently utilised.

2012/09

Look at the current transition processes between youth and adult services for both offenders and drug / alcohol misusers to ensure that people are not dropping out of treatment / support.

2012/10

Ensure problem profiles and more in-depth analysis is commissioned for specific issues throughout the year.
