8/12**      **Criminal Damage**

Members were provided with a presentation on Criminal Damage. The main areas highlighted were:-

- Public Confidence
- Performance Measures
- Criminal damage figures as a proportion of overall crime
- Repeat Victims
- Top Five Wards with 30 or more offences Jan- Mar 2012
- National Intelligence Model
- Safer Stockton Partnership Response
- Partnership Challenges 2012/13

Members of the partnership were asked to consider three questions:-

- What can the partnership do/and who is going to do what and by when?
- Public: What can they do or should the partnership do/ who is going to do what by when
- Third dimension is the police response to victims, offender and location

A number of suggestions were made:-

- Disseminate information more widely
- Consider what is happening on what nights and in what areas
- Encourage more reporting of criminal damage/graffiti etc.
- Work with YOS and in Schools

12/12**      **Alcohol Strategy Action Plan**

The Stockton-on-Tees Alcohol Strategy was implemented in April 2010. The Strategy was a 3 year Strategy with a 2 year Action Plan within it. The 1 year plan for 2012-2013 had been developed to ensure that the strategic aims of the Stockton-on-Tees Alcohol Strategy were continuously achieved. This plan had the needs of young people threaded throughout it but also took into account the responsibilities across both adults and children's services.

Discussion was held on the number of people admitted to hospital as a result of alcohol intake. An alcohol specialist nurse was now in post and screening was taking place. Other schemes were also being considered.

It was felt that there could be further changes when the Health and Wellbeing Board was fully operating.

AGREED that the report be noted.

14/12**      **TB4UD Evaluation**

The Think B4U Drink Campaign had been active in the area since 2005, and employs a range of activities, themes and resources to promote the awareness of alcohol consumption and alcohol-related harm issues across the Borough of Stockton.

Members were provided with the key findings from the evaluation following an in-street survey of Stockton residents, focus group discussions. Stockton's Multi Agency Alcohol Crime and Disorder group met Friday 9th March 2012 and discussed the next steps for TB4UD. The TB4UD current budget stands at £12K. A number of suggestions were put forward for the progression of the

Think B4U Drink campaign as highlighted within the report. Feedback from Alcohol Crime and Disorder group was also provided.

An opportunity for funding from Baroness Newlove had been submitted in order to increase the budget to enable further advertising and work as suggested within the report and to increase the promotion of the TB4UD campaign message. It was anticipated that a decision on the funding would be announced by 14th May, 2012.

AGREED that the report be noted.

15/12**      **New National Alcohol Strategy**

The Government on 23rd March 2012 launched its much anticipated Alcohol Strategy. Balance had looked behind the headlines and drawn out the key points into this summary.

The Government will:

- Introduce a minimum unit price for alcohol.
- Consult on introducing a ban on multi-buy promotions.
- Give stronger powers to control the density of licensed premises and make health a licensing objective for this purpose.
- Give areas the powers to restrict alcohol sales if late opening is causing problems through extended powers to make Early Morning Restriction Orders.
- Introduce a new late night levy so that those businesses that trade into the late night contribute towards the cost of policing.
- Pilot sobriety schemes for those people whose offending is linked to excessive alcohol consumption.
- Support hospitals to tackle unacceptable drunken behaviour at A&E.

Building on its Responsibility Deal, the Government would:

- Give consumers a wider choice of lower strength products in both the on-trade and off-trade, taking one billion units out of the market by 2015.
- Extend a challenge to all of industry to make more progress, more quickly on the responsible production, sale and promotion of alcohol.

Further detail was provided within the full summary document provided to Members.
