PCC Candidates Responses

48/12** **Drug Related Offending**

Members were presented with a report on drug related offending. The report outlined that reducing drug related offending is the fourth key issue in the 2011-2014 Safer Stockton Partnership Community Safety Plan.

The goals of this issue were to increase the effectiveness of treatment services and offender management in reducing the amount of drug related offending in the borough.

The report provided a summary of the issues which were relevant to reducing drug related offending.

Members then discussed the figures / issues around drug related offending. The following points were raised by Members:-

- * Not surprised figures are down as users are now taking cheaper alternative drugs that do not require them to go out and commit crime
- * There is an issue of what people are being tested for at the police station
- * Crime figures are good but there are still health issues to pick up on
- * There are still issues with low level asb

AGREED that the report be noted.

49/12** **Joint Health & Wellbeing Strategy**

Members were provided with a copy of the Consultation Briefing Note for Joint Health and Wellbeing Strategy Consultation (2013 – 2018) – Stockton-on-Tees.

The Stockton-on-Tees Health and Wellbeing Board were developing a Joint Health and Wellbeing Strategy. The purpose of this strategy was to set out how the health and wellbeing needs of the population of Stockton-on-Tees would be addressed over the coming years. The strategy focuses on improving health and wellbeing, tackling health inequalities, and considered the wider determinants of health such as housing, education and the environment.

The consultation period ran between 12th July and 25th August 2012.

All people who were interested in the health and wellbeing of those who live and work in the Borough were invited to participate in this consultation. There were also a number of public engagement events which members of the public had been invited to.

AGREED that the consultation document be noted.

Members received a presentation on Use of Restorative Justice in DTV Probation Trust. The presentation covered the following key areas:-

51/12** **Recorded Crime & Disorder**

Members were provided with the recorded crime and anti-social behaviour figures for April - June 2012/13 compared to the same period in 2011/12 . Overall crime was currently down by 8.3% and ASB incidents were down by

28.1%. Shoplifting was now included as a separate category but it was also included within other theft.

AGREED that the recorded crime and disorder figures be noted.

SSP 52/12 Community Safety Q1 Performance Monitoring

Members were informed that it was no longer possible to monitor target 3.1 Most Serious Violent Crime due to changes in recording practices. The Home Office made a number of amendments to the counting rules for recorded crime as of April 2012 which included some of the codes previously used to formulate Most Serious Violence (MSV).

A new target to reduce Violence With Injury (VWI) was being proposed as an alternative to monitor the more serious offences of violence within Stockton. This measure was very similar to the previous MSV measure in that it included homicide, assaults with injury and causing death by dangerous driving but it was made up of the new HO codes as provided within the report.

Members were provided with a copy of the Community Dashboard and the targets and action plan for 2012/13.

AGREED that the Community Safety Quarter 1 Performance Monitoring report be noted.

SSP 53/12 YOS Q1 Performance Monitoring

Members were provided with the Quarter 1 Performance Monitoring for the Youth Offending Service.

AGREED that the YOS Q1 performance monitoring be noted.

SSP 54/12 Alcohol Strategy Monitoring/Action Plan

The Stockton-on-Tees Alcohol Strategy was implemented in April 2010. The Strategy was a 3 year Strategy with a 2 year Action Plan within it. The 1 year plan for 2012-2013 had been developed to ensure that the strategic aims of the Stockton-on-Tees Alcohol Strategy were continuously achieved. This plan had the needs of young people threaded throughout and covered responsibilities across both adults and children's services.

AGREED that the Alcohol Strategy Monitoring/Action plan be noted.

SSP 55/12 Putting Victims First - More Effective Responses to Anti-social Behaviour - Government White Paper on ASB Powers

The government published the Putting Victims First White Paper in May 2012. The paper sets out how the Government intend to implement changes aimed at improving the response to anti-social behaviour. The White Paper aimed to:

- Improve the understanding of the needs of victims, including those at high risk
- Provide frontline professionals with more freedom to do what they know works
- Empower communities to get involved in tackling anti-social behaviour,

including giving victims and communities the power to ensure action was taken to deal with persistent anti-social behaviour via the 'community trigger'

- Make it easier to demonstrate in court the harm victims were suffering
- Provide professionals with quicker, formal powers, intended to be more effective
- Provide a faster eviction process for the most anti-social tenants
- Tackle underlying issues that drive antisocial behaviour, such as drink and drugs, mental health issues, troubled family backgrounds and irresponsible dog ownership.

The report provided an overview of the White Paper highlighting the key changes and a number of issues that the partnership may wish to consider.

AGREED that the report be noted.

SSP 56/12 **Case Studies - Five Prolific Shoplifters**

At the previous meeting of the Partnership a discussion took place about the prevalence of shop thefts and the impact this was having on recorded crime. It was identified that six High Crime Causers being managed by the IOM team were responsible for committing 88 convictions out of 154 amassed by the 30 High Crime causers under supervision during 2011/12. The majority of these crimes were shop thefts.

Members were provided with a breakdown of key factors in the history of the six people as previously identified

The IOM team were currently conducting interviews with the individuals in an attempt to motivate them to desist from their persistent offending.

AGREED that the report and information be noted.

SSP 57/12 **Diversion from Re-offending**

Members were provided with the notes of a visit to Hull on 5 July to discuss their award-winning Minerva Project.

Members of the Partnership were asked to consider the project outline, and whether they would support attempts to adopt a similar approach in Stockton. If there was support for this, then the next stage would be to prepare a Business Plan with outline costings.

Further thinking since the visit has involved the following suggestions:-

(a) a partnership with an existing charity may avoid the need to establish a CIC;

(b) given that any Stockton scheme would be a much smaller scale than the Minerva Project in Hull, and that the initial funding would be much less generous, two areas of work which may commend themselves were painting and decorating, and woodwork. The IOM scheme already had some experience of the latter, in partnership with the Shaw Trust, producing wooden benches, bird tables etc, and there had been some interest expressed in buying these.

(c) there may be some role for local prisons i.e. HMP Holme House and/or HMP Kirklevington; and

(d) there may be some mileage in seeking interest from the Further Education sector.

On 20 July the Big Lottery Fund made a directly relevant announcement about a new funding programme for people with multiple and complex needs.

AGREED that:-

1. The principle of attempting to replicate the Minerva Project approach in Stockton be supported.
2. The Partnership seek funding for this approach and for continuing work with sex workers via the Big Lottery Fund's multiple and complex needs programme.
