Consultation: Local Council Tax Support (LCTS) Scheme

Background

The Government is abolishing the current Council Tax Benefit (CTB) scheme and all Councils in England and Wales must replace this with a new 'Local Council Tax Support Scheme' (LCTS) by April 2013.

In addition to the move from a national to a local scheme the budget to fund the LCTS has been cut by at least 10%. This cut in funding means that the Council has to make some difficult decisions about who will get financial support to help pay their Council Tax bill.

The Council has developed some ideas about how it can do this best and has developed a draft LCTS. However, before the Council makes any final decisions it is asking everyone who is either interested in or likely to be affected by the new system to let us know what they think about those ideas. The Council will then consider these views when agreeing the final scheme.

Timescales

The LCTS consultation will run between Monday 13th August and Friday 19th October 2012. Consultation results will be reported to Cabinet on 29thNovember 2012. Those results and Cabinet's recommendations for a new LCTS will be considered by a full meeting of Council on 23rd January 2013. This meeting will make the final decisions about the new LCTS for Stockton-on-Tees.
