RECORDED CRIME & DISORDER

This report sets out the recorded crime and anti-social behaviour figures for end May 2013 compared to the same time period in 2012.

Statistics utilised for this report, with exception of crime rate per 1000 population, have been obtained from Cleveland Police Performance Management documents.

Table 1 shows that to date (end May 2013), public reported crime has increased by 5.3%, equating to 86 more victims of crime. Although not shown above this compares with overall force reduction of 5.6% and comparisons within Cleveland as follows – Hartlepool (-3.2%), Redcar&Cleveland (-1.1%) and Middlesbrough (-7.2%).

Although at present there is an increase of 5.6%, the graph on the following page relating to projections for end 2014, shows that if the daily average is maintained, then crime levels will increase only by 0.7%. This compares to 1.4% increase for Middlesbrough, 2% for Redcar & Cleveland, however a decrease of 3.1% in Hartlepool. This would give an overall Force increase of 0.6%.

By March 2016, Cleveland Police has set a new 3 year target to reduce the number of publicly reported crime (against a baseline position of 35,144 offences recorded during 2012-13). Public reported crime, not total crime (total crime includes police generated) was used by both police and local authority for the end of the financial year reporting to the public.

In relation to Table 1, reductions can be seen in several areas:- Violence, in particular, Violence with injury (-52 crimes), Sexual offences (-9), Domestic burglary (-9) and Robbery offences (-2).

Theft offences are of note, with shoplifting showing an increase of 50 crimes. This rise early into the financial year is of note bearing in mind that for the end 2012/13 shoplifting had increased by 183 crimes (14.5%).

Research of shoplifting in April and May shows that the increase is mainly occurred in April when there were a further 41 crimes reported, compared to increase of nine in May. Although not shown on the above table, the detection rate for shoplifting has actually increased when compared to 2012/13 from 67.1% to 69.5% (+2.4%).

DV related crime

Of the above crimes, 7.7% were recorded as domestic related - 132 crimes (compares to 167 previous year, accounting for 9.3% total crime). Of the DV related crimes, the majority were linked to violence (74%), followed by damage (14%). These are crimes that have crime indicator field recorded as being domestic related.

Hate crime



So far this year, the number of crimes with a hate qualifiers increased by 26.7% with the Positive outcome rate increasing by 36.5% to 63.2%.. The increase is shown in green as it is seen as a positive in reporting.

The graph on page 2 illustrates monthly crime levels since April 2012 along with projections for end March 2014.

Assuming the current 'daily average' level of recorded crime is maintained, an annual increase of 0.7% is anticipated this year.

Detection rate

To date, the detection rate for public reported crimes stands at 27.4%, reduction of 3.5% on last year.

The table on previous page shows that Stockton continues to have the lowest crime rate per 1000 population for **public reported crimes** with Middlesbrough the worst performing.

Redcar has lowest rates for majority of crime categories with Middlesbrough the worst performing.

Stockton however is second best performing in majority of crime types and as table shows, the best for Burglary dwelling/Non domestic and Criminal Damage/Arson.

Table 4 shows police generated crime in comparison to last year along with total crime levels showing an overall increase of 89 (5%).

Changes in percentages in relation to police generated crimes are now highlighted in grey by the Performance section. This is due to fact that it is difficult to state if a reduction or increase is a positive or negative for this type of offence. This is particular of note for drug offences, which can increase if there have been numerous operations carried out in a particular month.



The above chart displays ASB calls linked to Stockton during rolling 12 month period, along with yearend projections.

Assuming the current 'daily average' level of antisocial behaviour is maintained, an annual increase of 13.1% is anticipated this year.

Table 7 illustrates incident types for ASB between April to May 2013 compared to last year. This shows total increase of 212 calls (10.2%).

Although not shown on the above table, comparisons with other three local authority areas also show increases in ASB in Hartlepool (+15.2%) and Redcar (+3.2%) however decrease of 5.6% in Middlesbrough.

Research of ward areas within Stockton Borough shows no significant increases between April and May and consultation with police analysts show no ward areas raised for extra attention.

Table 8 –The final tables shows rates per 1000 population for each local authority area showing that Redcar (11.79) has the lowest rate for ASB however Stockton is just shortly behind (11.9).
