

# Safer Stockton Partnership

Members were presented with a report from the Tactical Team Analysts - Alcohol related crime and ASB in Stockton LPA - April - September 2014.

86/14**      **Recorded Crime & Disorder**

Consideration was given to a report that provided an overview on crime and anti-social behaviour levels in the borough of Stockton between April to September 2014.

The Key findings were:-

- Between April 2014 and September 2014, both publicly reported (-12.1%) and total crime (-11%) had reduced in the borough of Stockton.
- This equated to 647 fewer victims of crime.
- Comparisons with neighbouring local authority areas also showed that Stockton had seen the biggest reduction to date.
- Stockton also remained the safest place to live in relation to rates per 1000 population for both crime and ASB.
- Despite overall crime reducing, there still continued to be slight increases in offences of violence (52 offences/+5.8%), rape (10 offences/+23.08%) and other sexual offences (10 offences/+13.9%).
- There were no concerns with regards to knife, gun or serious violence in Stockton.
- However there were excellent reductions in several key crime areas: Personal robbery (-16 crimes/-39%), Burglary non-domestic (-102 crimes/-24.5%), Vehicle crime (-120 crimes/-28.7%) and Shoplifting (-102 crimes/-12.6%).
- Burglary dwelling had also reduced this month and was showing a 3.1% decrease on last year. Burglary offences in September also reduced by nearly half with only 27 offences compared to 45 in September 2013.
- The forecast for the end of financial year was also projecting a reduction of 6.1%, the biggest anticipated decrease in crime levels when compared to neighbouring local authorities.
- ASB was also showing a positive picture this period and the Borough was the only local authority area to see a reduction (-1.8%).
- Despite the decrease in ASB, if levels continued at the current rate, then a 6.5% increase was anticipated however the Borough would still have the lowest increase when compared to Hartlepool (13.7%), Middlesbrough (17.9%) and Redcar & Cleveland (17.4%).
- There had been no significant changes to offending locations when compared to last year.
- There were no new emerging issues in relation to crime and disorder in Stockton borough.

Members discussed issues around Hartington Road. The representative from Catalyst reported that there were lots of concerns regarding drug and alcohol abuse and these issues had been raised at community forums. It was reported that there was some multi-agency work happening in the Hartington Road and an action plan was being produced.

AGREED that the report be noted.

88/14**      **Domestic Abuse Strategy Q1 & Q2**

Consideration was given to the Domestic Abuse Performance Report April 2014 - September 2014 and the Domestic Abuse Action Plan for 2014/15.

The Domestic Abuse Performance Report provided an overview on research and analysis conducted on a number of data sets linked to domestic abuse within the borough of Stockton.

- Cleveland Police crime and incident reports
- Children, Education and Social Care First Contact Team, SBC
- Housing Options, SBC
- Safe at Home scheme, Community Safety Dept, SBC
- A&E Data, National Health Trust.
- Harbour performance data

The report focused on data from each of the above sources however will feature within differing contexts of the report. For example, when looking at what was occurring in relation to domestic abuse, this would feature data from police incidents and crime performance statistics along with other relevant information.

A number of different databases had been utilised to provide this data which often did not provide personal or in depth information and therefore there were some constraints in reporting.

This document was previously utilised in the Domestic Abuse Strategy Meetings however the report was a work in progress in terms of trying to identify a wide factor of data that could enhance the report and would feed into the strategy through the Health and Wellbeing meetings.

A revised Domestic Abuse strategy was implemented in July 2014 and set out how the Council would work with its partners such as Police and health as well as voluntary, community and social enterprise organisations to promote ways to prevent people being abused and provide support and protection for those who may need it.

The document was shaped through consultation with people who had experienced domestic violence and abuse, their families and perpetrators. Social Care staff who work with families affected by domestic abuse were also asked for their views.

The strategy would be in place until March 2017 and run alongside an identified action plan with set targets and performance measures.

The Domestic Abuse Strategy Action Plan for 2014/15 identified a need to focus on Awareness and Education, Early Intervention and Support and Protection.

The actions were all encompassed within these themes. The actions had been segmented into sections relating to Communications and Consultation, Data Collation and Information Sharing, Education and Training and Development of Support Pathways as these were the four key priority areas identified for action during the consultation process undertaken from June to December 2013.

AGREED that:-

1. The Domestic Abuse Performance Report April 2014 - September 2014 be noted.
2. The Domestic Abuse Action Plan for 2014/15 be noted.
