### **Partnership approach to tackling crime in Stockton**

The Chair introduced the item. He outlined that there was significant pressure on crime at the moment. The issue for the partnership was how to respond and what was going to be the strategic approach. The communication plan would also be critical to the partnership.

The following presentations were given on the Partnership's approach to tackling crime in the Borough.

ARCC CRC Presentation - IOM. The presentation covered the following key areas:-

- Interventions
- Re-offenders and enhanced interventions
- Stabilisation and sustainable lifestyle
- Social Action
- Community Payback

The Partnership felt that this was a good news story and was validation for the route that was taken in that the service was a not for profit organisation. It was also felt that someone from ARCC CRC should attend future meetings of Catalyst. The Partnership also felt that it was important that they could feed into the process for identifying priority cases.

Violent Crime. The presentation covered the following key areas:-

- Force Overview
- NCRS Compliance
- Compliance Benefits
- Violence Increases in Cleveland Police
- Changes to Recording
- Scanning Results
- Key Wards
- Breakdown by Violence Type
- Night Time Economy
- Partnership Working

The Partnership felt that the impact of domestic abuse was significant and that the balancing of police resources had to be right to tackle the issue.

With regard to the Domestic Abuse top 10 repeats meeting the Community Safety Manager had been frustrated that the level of referrals were not always coming through in time which was holding up progress. This is being addressed through the newly created Domestic Abuse Operational Group.

Commissioning of Substance Misuse Services. The presentation covered the following key areas:-

- Current Approach
- Drug Treatment Model
- Drug Misusing Offender Management

It was reported that if people were in full recovery they were far less likely to re-offend. The testing programme was still being honed to find the most effective model.

Working in Hartington Road. The presentation covered the following key areas:-

- Changes to management structure
- Employment Initiative
- Number of Voids
- 100% Placement Rights
- Targeted Work

The Community Safety Manager reported that Friends of Trinity Green had requested an update on the work that is being carried out in Hartington Road and the neighbouring Trinity Green. A public meeting has been arranged and officers from the Community Safety team will be attending.

The Partnership felt that there was some very good information sharing. The Chair reported that he would sign a letter of support if needed to help ensure future funding for the dedicated support officer working within Hartington Road.

Restorative Practice (RP). The presentation covered the following key areas:-

- Prolific and Priority Offenders
- Benefits of RA
- Offender / Harmer Perspective
- Participation Model

From a YOT perspective RP was being embedded in their service. Every victim of youth crime was contacted to see if they would be interested in RP. The wishes of the victim would be paramount in the process.

Crime Prevention and work in schools. The presentation covered the following key areas:-

- Work in Schools
- Safe at Home
- Preventions
- DA Medium Repeats

ASB and Youth Direction/Joint Working. The presentation covered the following key areas:-

- Joint Patrol Service

- Objectives
- Patrols
- Results
- Anti-Social Behaviour

With regard to the Joint Patrol Service it had been delivered in Norton North. There had been some very good engagement and it had been a key factor in bringing down ASB in the area. It was felt that there the service brought good benefits to the Borough for relatively low costs.

The Partnership was hopeful that some figures could be brought to them in 6 month's time.

It was reported that there was a hope that the service would be expanded in the future.

Cleveland Connect. The presentation covered the following key areas:-

**SSP 48/15 Stockton Town Centre Retail Crime**

Chief Inspector Marc Anderson reported the Stockton Town Centre retail crime figures.

The Police had been targeting stores to try and get them to be proactive and prevent shoplifters from actually entering the shops in the first place.

Funding availability was being looked at but it was reported that some retailers would not contribute any funds.

The Community Safety Manager reported that two dedicated Town Centre Officers were working closely with the Police.

The Chair reported that he would write to the retailers if an evidence base could be given.
