The Domestic Abuse Action Plan had a revised layout, there were now fewer actions and less progress details.

Members discussed the joined-up working of the different Boards involved in domestic abuse. Members also discussed the issue of domestic abuse and queried best practice at other local authorities that had brought down their figures and it was felt that this should be further investigated.

The Partnership was also provided with a copy of a report that had been prepared to assist with the newly created Domestic Abuse Tactical / Operational Group.

- b. The group were provided with a copy of minutes and given a verbal overview of the last operational meeting.
- c. The Partnership was also provided with a copy of a report on the Domestic Abuse Medium Repeats Group.

The group was set up in 17th December 2012 and reformed in November 2013 and existed as a specialist group that provided an opportunity for the exchange of information, ideas and experiences, in order to monitor the on-going actions for all agreed cases. These cases were a specific list of vulnerable people who had been identified as medium repeats for domestic abuse, that were not referred to MARAC in Stockton.

This group provided an opportunity for a multi-agency group to meet, who were committed to working towards early intervention for those living with domestic abuse. This approach enabled the development of a response which would maximise the sharing of information and promotion of collaborative working to promote engagement of support services and to identify and utilise any funding resources available.

## **8 Recorded Crime and Disorder**

The Partnership was provided with a report that gave an overview on crime and ASB in the borough of Stockton between April 2015 and September 2015.

These details had been taken from Cleveland Police Performance statistics and were restricted due to crime and ASB details not being released to the general public at the time of writing.

In relation to crime statistic for Darlington, who formed part of the Tees Valley area, they were not available at time of writing. Therefore the research would provide comparisons to Middlesbrough, Hartlepool and Redcar & Cleveland local authority areas based upon figures obtained from Cleveland Police.

The Partnership discussed the figures and the fact that the figures for Stockton had now gone up and not down as predicted.

**12 Deliberate fires in Stockton**

The Partnership was presented with a report on deliberate fires in Stockton.

The profile had been prepared to provide a concise report of F3 fires in Stockton district for time period 1st January to 21st October 2015. The report also looked specifically at fires in Stockton Town Centre, Newtown, Norton North and Norton South wards for time period March to April 2015.

The figures highlighted a large increase in the number of secondary fires occurring within Stockton this calendar year. The month on month comparison had shown that each month January to July had shown an increase when compared to the same month in 2014.

The CLO had initiated a multi-agency meeting to attempt to combat the issue, identify culprits and take action as necessary. Partners were keen to assist in resolving the issue and included SBC Enforcement, SBC ASB team, Thirteen group, Police, SBC Youth Services and British Transport police.

The evidence suggested the success of this multi-agency approach to problem solving with the demonstration of both dramatic and efficient results. While the

whole episode lasted approximately six weeks it was felt that this time period would have been longer without the collaborative work of all agencies.

Appreciation of this approach and successful resolution was extended to all agencies involved in the exercise.

Partners had established a successful working practice model for future use should it ever be needed again. Arson awareness needs to continue to be increased and this must be provided from all agencies. This was commencing with the establishment of joint initiatives with social landlords. The biggest factor however in reducing levels of arson would be ultimately down to funding.
