## Update on Prevent

Members were given an update on Prevent.

Members were aware the Counter Terrorism and Security Act 2015 placed a requirement on local authorities, in the exercise of their functions to have due regard to the need to prevent people being drawn into terrorism (Chapter 1, Section 26).

While the responsibilities of local government bodies would not fundamentally change with the commencement of the Prevent Duty. By placing a statutory duty on local authorities the Government intends to ensure that there was consistency across all local authorities and increased opportunities to share best practice.

The Prevent Duty came into effect on the 1st July 2015; local authorities were required to fulfil a range of responsibilities as articulated in the Prevent guidance. The update gave a reminder of the categories.

The Cleveland Prevent Silver Group also continued to make progress on the 'rolling action plan' which covered all aspects of the duty. From a Stockton perspective there was a dedicated website resource which provided individuals with information, links to the Home Office guidance and a copy of the referral form to report any concerns.

The roll out of training and awareness raising to staff continued and training had been carried out to all Directorates in the authority. To date in 2016/17 410 individuals had received additional awareness raising training on Prevent.

Following the implementation of Prevent within local authorities the Home Office had developed a peer review process and had recruited a number of Local Authority peers to support this work. The first peer reviews would take place and findings would be made available to other local authorities in an effort to improve the quality and consistency of approach to Prevent. To accompany the process, draft guidance had also been prepared by the Home Office for circulation to Local Authorities. Once approved the document would be shared with members of the SSP.

Members will be aware that on 12th December 2016 the Far-Right group 'National Action' was classified as a proscribed organisation. As a result of this classification, the group is now considered as a terrorist organisation. Any individual membership or support of this group is classed as a criminal offence.

The National Police Chiefs Council (NPCC) was launching a new Counter Terrorism advertising campaign and branding platform on Monday 6 March 2017. ACT (Action Counters Terrorism) was the new branding platform and had been user-tested with members of the public and stakeholders. This new platform had been developed to bring together all public facing counter terrorism communications, past and future, under one unified banner.

ACT created one overarching call to action and it was envisaged that it would drive new behaviours and encourage communities to work proactively to defeat terrorism.

The first new campaign to run on the ACT branding platform would be the 2017 National Counter Terrorism Awareness Campaign. This campaign would be launched on 6th March and the key communication objectives were detailed in the update.
