Re: PCC Funding

I refer to your funding applications to the Police and Crime Commissioner for Cleveland for the following:

- Independent Domestic Violence Advisers £120,000 (£30,000 for each CSP area) annually from April 2017 – March 2020 a total of £360,000.
- Community Resolution Service – 4 co-ordinators £96,000 (£24,000 for each CSP) from April 2017 – March 2020 a total of £288,000.
- Targeted Youth Outreach Service £148,000 per annum (£37,000 for each CSP area) from April 2017 – March 2020 a total of £444,000.
- Youth Offending Team Triage and Out of Court disposals £200,000 (£40,000 Hartlepool YOT; £60,000 Stockton YOT and £100,000 South Tees YOT) per annum from April 2017 – March 2020 a total of £600,000.

The meeting administering the funds has now considered all funding requirements and applications, and I am pleased to inform you that;

- A grant to provide an Independent Domestic Violence Advisers Service of £120,000 2017/2018 and £120,000 in 2018/2019 will be granted. Service provision will be reviewed in 2018/19 together with the outcomes of the Police Transformation Fund Domestic Abuse Project.
- A grant of £60,000 (£15,000 for each CSP) to extend the targeted Youth Outreach Service for a further 6 months from 1st April 2017 – 30th September 2017 pending the outcomes of a review undertaken by my office starting in January 2017.
- A grant of £200,000 for 2017/18 for Youth Offending Team Triage and Out of Court disposals (£40,000 Hartlepool YOT; £60,000 Stockton YOT and

£100,000 South Tees YOT). To be reviewed by the Local Criminal Justice Board support team when appointed.

Community Resolution Service – I have made a commitment in my 2016-2021 Police and Crime Plan to further developing restorative justice. Grant funding that I have been allocated by the Ministry of Justice to deliver services locally did not include provision for a community resolution service. I will continue to fund a Cleveland wide RJ co-ordinator and RJ capacity within the Integrated Offender Management Hub. In addition to this during 2017, I will review Restorative Cleveland with a view to developing the service.

You will be aware that from 1st April 2016 I commissioned a new Victim Care and Advice Service, provided by Safe in Tees Valley to provide support services to victims of crime. In 2017, I would like to work with partners through the Victim and Witness Strategic Planning Group to develop a dedicated support service for vulnerable victims of anti-social behaviour and have allocated a budget for this service.

Grant agreements will shortly be issued to you by a member of my team, which should be signed and returned promptly. Reporting requirements from you will be contained within, along with details of payment schedules.
