Police and Crime Plan 10-point plan

More Police on our Streets

- Increase the number of Special Constables
- Gain support for a council tax reduction for Special Constables
- Bring Hartlepool Custody back into use
- Further embed Neighbourhood Policing
- Support the mental health and wellbeing of the Cleveland Police Workforce

Effective, Quality Support to Victims & Witnesses of Crime

- Introduce a new approach to supporting victims through service re-design and delivery
- Monitor adherence to the Victims Code of Practice
- Monitor the impact of COVID 19 on victim and witness services
- Increase the workforces awareness of specialist crime types including Hate
 Crime and Rural Crime
- Increase the provision of crime prevention support
- Host in collaboration with Teesside University a Business Summit focusing on cyber crime

Bringing Offenders to Justice

- Work with probation to support visible and worthwhile work in local communities
- Increase the use of Out of Court Disposals whilst enhancing the integrated offender management programme
- Strengthen Restorative Justice by exploring and building opportunities
- Support and monitor progress on the development of Integrated Offender
 Management to reduce re-offending
- Work with partners to create and deliver a Domestic Abuse Perpetrator Strategy
- Support tougher sentences for people who assault emergency workers

Getting Tough on Drugs & Gangs

- Support targeted operations such as Operation Endeavour
- Work with partners including Public Health to ensure a holistic approach to tackling drugs across the area
- Increase public understanding of County Lines and how to report intelligence
- Increase stop and search ensuring fairness and proportionality

Tackling Anti-social Behaviour Head-on

- Encourage and promote how communities can report ASB
- Commission diversionary services to prevent young people getting involved in anti-social behaviour
- Increase awareness and understanding of the Community Trigger process to ensure victims are getting the right service
- Seek opportunities to understand how ASB can be dealt with swiftly through early intervention

Prevent, Reduce & Tackle Serious Violence

- Continue to lobby government for additional funding for to establish a
 Violence Reduction Unit
- Invest funding in community based activities to prevent serious violence
- Launch a Serious Violence Strategy with support from Community Safety
 Partnership colleagues
- Ensure Police Officers are equipped to attend serious violence incidents

Use Technology to Combat Crime

- Create and develop an App to enable the public to make reports to Cleveland
 Police
- Maximise the use of Drone capability to tackle and disrupt Crime in Cleveland
- Make best use of technology to manage offenders including GPS and Sobriety Tagging
- Explore the use of DNA Tagging spray
- Bid for exploratory funding to trial facial recognition software

Building Confidence in Our Communities

- Launch a new open and transparent strategy that enables residents to engage directly with the OPCC
- Regularly seek public feedback to understand confidence in Cleveland Police
- Use robust scrutiny to hold the Chief Constable to account
- Ensure the force control room delivers a 1st class quality service for our residents

Tackling Violence Against Women & Girls

- Analyse survey to understand Women's and Girls feelings of safety
- Work with local partners to submit bids to the Home Office / Ministry of Justice Funding streams
- Work with PCC colleagues in Durham and Northumbria to commission a highquality regional Sexual Assault Referral Centre (SARC) provision.
- Monitor the introduction and development of Cleveland-wide Independent Sexual Violence Advisor (ISVA) Service to ensure victims of sexual assault have effective support
- Oversee and support the Domestic Abuse Deep Dive review which aims to improve the response across Cleveland

Effective Policing & Criminal Justice System

- Monitor Cleveland Police progress against PEEL Report Causes of Concern
- Support the development of the new North East Probation Service and their regional reducing re-offending strategy
- Ensure victims of Domestic Abuse and Sexual Violence can give evidence to court remotely through the provision of IT infrastructure
- Work with the Local Justice System to ensure timely court process
