

## **Members - Declaration of Interest Guidance**

#### KEY - Declarable interests are:-

- Disclosable Pecuniary Interests (DPI's)
- Other Registerable Interests (ORI's)
- Non Registerable Interests (NRI's)





## **Table 1 - Disclosable Pecuniary Interests**

| Subject  | Description   |
|--|---|
| Employment,<br>office, trade,<br>profession or<br>vocation | Any employment, office, trade,<br>profession or vocation carried on for profit or gain  |
| Sponsorship  | Any payment or provision of any other financial benefit (other than from the council) made to the councillor during the previous 12-month period for expenses incurred by him/her in carrying out his/her duties as a councillor, or towards his/her election expenses.<br>This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.   |
| Contracts  | Any contract made between the councillor or his/her spouse or civil partner or the person<br>with whom the<br>councillor is living as if they were<br>spouses/civil partners (or a firm in which<br>such person is a partner, or an incorporated body of which such person is a director* or<br>a body that such person has a beneficial<br>interest in the securities of*) and the council —<br>(a) under which goods or services are to be provided or works are to be executed; and<br>(b) which has not been fully discharged.  |
| Land and property  | Any beneficial interest in land which is within the area of the council.<br>'Land' excludes an easement, servitude,<br>interest or right in or over land which does not give the councillor or his/her spouse or<br>civil partner or the person with whom the<br>councillor is living as if they were spouses/ civil partners (alone or jointly with another) a<br>right to occupy or to receive income.  |
| Licenses   | Any licence (alone or jointly with others) to occupy land in the area of the council for a month or longer  |
| Corporate<br>tenancies                                     | Any tenancy where (to the councillor's knowledge)—<br>(a) the landlord is the council; and<br>(b) the tenant is a body that the councillor, or his/her spouse or civil partner or the<br>person with whom the councillor is living as if they were spouses/ civil partners is a<br>partner of or a director* of or has a beneficial interest in the securities* of.   |
| Securities   | Any beneficial interest in securities* of a body where—<br>(a) that body (to the councillor's<br>knowledge) has a place of business or<br>land in the area of the council; and<br>(b) either—<br>(i) the total nominal value of the<br>securities* exceeds £25,000 or one hundredth of the total issued share<br>capital of that body; or<br>(ii) if the share capital of that body is of more than one class, the total nominal value of<br>the shares of any one class in which the councillor, or his/ her spouse or civil partner or<br>the person with whom the councillor is living as if they were spouses/civil partners have a<br>beneficial interest exceeds one hundredth of the total issued share capital of that class.<br>es a member of the committee of management of an industrial and provident society. |

' 'director' includes a member of the committee of management of an industrial and provident society.

\* 'securities' means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.



## **Table 2: Other Registrable Interest**

You must register as an Other Registrable Interest:

a) any unpaid directorships

b) any body of which you are a member or are in a position of general control or management and to which you are nominated or appointed by your authority

- c) any body
- (i) exercising functions of a public nature
- (ii) directed to charitable purposes or

(iii) one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union) of which you are a member or in a position of general control or management
